

**AN ORDINANCE AMENDING CHAPTER 315, ARTICLE II, SECTION 8 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF WHARTON, COUNTY OF MORRIS, STATE OF NEW JERSEY**

BE IT ORDAINED by the Governing Body of the Borough of Wharton that Chapter 315 Vehicles and Traffic, Article II Parking, Section 8 Parking time limited on certain streets of the revised general ordinances of the Borough of Wharton is hereby amended as follows:

§ 315-8. Parking time limited on certain streets.

No person shall park a vehicle for longer than the time limit between the hours listed on any day upon any of the streets or parts of streets described below:
