ORDINANCE NO. 1649

AN ORDINANCE OF THE CITY OF WRIGHT CITY, MISSOURI, RE-ESTABLISHING AND MAKING PUBLIC A PROCEDURE TO DISCLOSE POTENTIAL CONFLICTS OF INTEREST AND SUBSTANTIAL PERSONAL INTEREST OF CERTAIN MUNICIPAL OFFICIALS.

WHEREAS, Sections 105.483 to 105.492 RSMo., imposes certain requirements relating to the filing of personal financial disclosure statements by administrative and elected officials of certain political subdivisions of the State of Missouri; and

WHEREAS, Section 105.485 RSMo., requires that any political subdivision establishing its own method of disclosing potential conflicts of interest and substantial interests biennially adopt an ordinance, order or resolution establishing and making public the City's method of disclosing potential conflicts of interest and substantial interests; and

WHEREAS, the Board of Aldermen of Wright City has adopted and established procedures relating to personal financial disclosure statements for its officials which procedures have been codified in Chapter 145 of the Wright City Municipal Code; and

WHEREAS, the Board of Aldermen, in compliance with state law, wishes to make public the City's method of disclosing potential conflicts of interest and substantial interests.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WRIGHT CITY, MISSOURI, AS FOLLOWS:

SECTION I. In conformance with §105.485.4 RSMo., the Board of Aldermen hereby adopts this Ordinance re-establishing and making public the City's method of disclosing potential conflicts of interest and substantial interests and re-establishes the procedures set for in Exhibit 1 as the City's official method of disclosing potential conflicts of interest and substantial interests. The Board of Aldermen further re-adopts and reapproves the financial disclosure form available at:

https://www.mec.mo.gov/WebDocs/PDF/Fillable/PFD/PFD Short.pdf

and attached as Exhibit 2 to be filed with the City and the Missouri Ethics Commission by each official, officer, employee and candidate required to make such disclosures by Sections 119.010 and 119.050 of Chapter 119 of the Wright City Municipal Code (attached as Exhibit 1). The Board therefore expressly excludes the City's officials, officers, employees and candidates from the filing requirements set forth in §105.483(11) and §105.485(2) RSMo., with regard to filing of financial interest statements as required by §105.485(2) RSMo.

SECTION II. Filing of Ordinance. A certified copy of this Ordinance shall be sent within ten days of its adoption to the Missouri Ethics Commission.

SECTION III. Effective Date. This Ordinance shall be in full force and effect from and after the date of its passage and approval and shall remain in effect until amended or repealed.

Exhibit 1

Chapter 119 Conflicts of Interest

Section 119.010 Declaration Of Policy.

[R.O. 1992 § 145.010; Ord. No. 395 § 1, 9-13-2001; Ord. No. 431 § 1, 8-14-2003; Ord. No. 544 § 1, 8-11-2005; Ord. No. 919, 8-24-2017; Ord. No. 974, 8-22-2019; Ord. No. 1002, 8-12-2021]

The proper operation of government requires that public officials and employees be independent, impartial, and responsible to the people; that government decisions and policy be made in the proper channels of the governmental structure; that public office not be used for personal gain; and that the public have confidence in the integrity of its government. In recognition of these goals, there is hereby established a procedure for disclosure by certain officials and employees of private financial or other interests in matters affecting the City.

- A. All elected and appointed officials as well as employees of the City must comply with Section 105.487 of Missouri Revised Statutes on conflicts of interest as well as any other state law governing official conduct.
- B. Any member of the Governing Body of the City who has a "substantial or private interest" in any measure, bill, order or ordinance proposed or pending before such Governing Body must disclose that interest to the Secretary or Clerk of such City and such disclosure shall be recorded in the appropriate journal of the City, substantial or private interest is defined as ownership by the individual, his spouse, or his dependent children, whether singularly or collectively, directly or indirectly of:
 - 1. Ten percent (10%) or more of any business entity; or
 - 2. An interest having a value of ten thousand dollars (\$10,000.00) or more; or
 - 3. The receipt of a salary, gratuity or other compensation or remuneration of five thousand dollars (\$5,000.00) or more per year from any individual, partnership, organization, or association within any calendar year.

A. Each elected official, candidate for elective office, the chief administrative officer, the chief purchasing officer, and the full-time general counsel shall disclose the following information by May 1, or the appropriate deadline as referenced in Section 105.487, RSMo., if any such transactions occurred during the previous calendar year:

- 1. For such person, and all persons within the first degree of consanguinity or affinity of such person, the date, and the identities of the parties to each transaction with a total value in excess of five hundred dollars (\$500.00), if any, that such person had with the City, other than compensation received as an employee or payment of any tax, fee, or penalty due to the City, and other than transfers for no consideration to the City; and
- 2. The date and the identities of the parties to each transaction known to the person with a total value in excess of five hundred dollars (\$500.00), if any, that any business entity in which such person had a substantial interest, had with the City, other than payment of any tax, fee, or penalty due to the City or transactions involving payment for providing utility services to the City, and other than transfers for no consideration to the City; and
- 3. The chief administrative officer and the chief purchasing officer and candidates for either of these positions also shall disclose by May 1, or the appropriate deadline as referenced in Section 105.487, RSMo., the following information for the previous calendar year:
 - a. The name and address of each of the employers of such person from whom income of one thousand dollars (\$1,000.00) or more was received during the year covered by the statement;
 - b. The name and address of each sole proprietorship that he owned; the name, address and the general nature of the business conducted of each general partnership and joint venture in which he was a partner or participant; the name and address of each partner or co-participant for each partnership or joint venture unless such names and addresses are filed by the partnership or joint venture with the Secretary of State; the name, address and general nature of the business conducted of any closely held corporation or limited partnership in which the person owned ten percent (10%) or more of any class of the outstanding stock or limited partnership units; and the name of any publicly traded corporation or limited partnership that is listed on a regulated stock exchange or automated quotation system in which the person owned two percent (2%) or more of any class of outstanding stock, limited partnership units or other equity interests;
 - c. The name and address of each corporation for which such person served in the capacity of a director, officer, or receiver.

A. The financial interest statements shall be filed at the following times, but no person is required to file more than one (1) financial interest statement in any calendar year:

- 1. Every person required to file a financial interest statement shall file the statement annually not later than May 1 and the statement shall cover the calendar year ending the immediately preceding December 31, provided that any member of the Board may supplement the financial interest statement to report additional interests acquired after December 31 of the covered year until the date of filing of the financial interest statement.
- 2. Each person appointed to office shall file the statement within thirty (30) days of such appointment or employment covering the calendar year ending the previous December 31.
- 3. Every candidate required to file a personal financial disclosure statement shall file no later than fourteen (14) days after the close of filing at which the candidate seeks nomination or election or nomination by caucus. The time period of this statement shall cover the twelve (12) months prior to the closing date of filing for candidacy.
- B. Financial disclosure reports giving the financial information required in Section 119.040 shall be filed with the City and with the Missouri Ethics Commission. The report shall be available for public inspection and copying during normal business hours.
