ORDINANCE NO. 1045

AN ORDINANCE LEVYING AND IMPOSING AN AD VALOREM TAX FOR THE CALENDAR AND FISCAL YEAR OF 2023 FOR: GENERAL MUNICIPAL PURPOSES; STREET LIGHTING PURPOSES; PUBLIC PARK PURPOSES; AND GENERAL OBLIGATION BOND PURPOSES.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WRIGHT CITY, MISSOURI, AS FOLLOWS:

SECTION I. There is hereby levied and imposed for the calendar and fiscal year of 2023 for the general municipal purposes, an ad valorem tax upon all real and personal property subject to taxation within the corporate limits of the City at the rate of **\$0.4853** on each One Hundred Dollars (\$100.00) assessed valuation.

SECTION II. There is hereby levied and imposed for the calendar and fiscal year 2023 for the lighting of streets, alleys and other public places within the City, a public health purposes, an ad valorem tax upon all real and personal property subject to taxation within the corporate limits of the City at the rate of **\$0.1803** on each One Hundred Dollars (\$100.00) assessed valuation.

SECTION III. There is hereby levied and imposed for the calendar and fiscal year 2023 for the establishment and maintenance of free public parks within the City, an ad valorem tax upon all real and personal property subject to taxation within the corporate limits of the City at the rate of **\$0.0901** on each One Hundred Dollars (\$100.00) assessed valuation.


SECTION IV. There is hereby levied and imposed for the calendar and fiscal year of 2023 an ad valorem tax upon all real and personal property subject to taxation within the corporate limits of the City at the rate of **\$0.1091** on each One Hundred Dollars (\$100.00) of assessed valuation to be collected for the purpose of paying as and when due principal of and interest on general obligation bonds as approved by the required percentage of qualified voters voting on the question at a duly noticed elections pursuant to article VI, §26 of the Missouri constitution and section 95.115 et seq. of the Revised Statutes of Missouri, as amended (and as set forth in section 402 of Ordinances No. 567 and No. 885 of the City).

SECTION V. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION VI. A cancellation of any part of this Ordinance by judgment or other orders shall in no wise affect any of its other provisions, which shall remain in full force and effect.
