**ORDINANCE #20-09**

**ORDINANCE PROVIDING FOR VARIOUS  
RECREATIONAL IMPROVEMENTS OR PURPOSES TO  
BE UNDERTAKEN IN AND BY THE TOWNSHIP OF  
JEFFERSON, IN THE COUNTY OF MORRIS, NEW  
JERSEY, AND APPROPRIATING \$74,620 THEREFOR  
FROM THE RECREATION TRUST FUND OF THE  
TOWNSHIP**

**BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP  
OF JEFFERSON, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:**

Section 1. The improvements described in Section 2 of this ordinance are hereby authorized as general improvements to be made or acquired by The Township of Jefferson, in the County of Morris, New Jersey. For the said improvements or purposes stated in said Section 2, there is hereby appropriated the sum of \$74,620 from moneys available in the Recreation Trust Fund of the Township.

Section 2. The improvements hereby authorized and the several purposes for which said appropriation is made are as follows: for the Recreation Department of the Township, the acquisition by purchase of two (2) push leaf blowers, one (1) truck tailgate leaf blower, one (1) utility trailer, one (1) spreader and one (1) lawn mower; the installation of fencing at Upper Field; the renovation of the senior center by the construction or reconstruction of decks and the Lodge Kitchen by the installation of a new ansel system; and the upgrade of the wells at Lakeside Park and Chamberlain Park including, for all of the foregoing, all necessary and appurtenant equipment, accessories, attachments, work and materials, and all engineering, legal, advertising and other costs associated therewith, and all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final adoption, as provided by law.
