**ORDINANCE #17-13**

**“ORDINANCE AMENDING CHAPTER 142 OF THE JEFFERSON TOWNSHIP MUNICIPAL CODE  
ENTITLED “ALCOHOLIC BEVERAGES” AND MORE PARTICULARLY SUBSECTION 142-1 ENTITLED  
“LICENSE FEES FOR PLENARY RETAIL CONSUMPTION LICENSE AND CLUB LICENSE”**

**BE IT ORDAINED** by the Township Council of the Township of Jefferson, Morris County, State of New Jersey that Chapter 142 of the Jefferson County Municipal Code, entitled “Alcoholic Beverages” is hereby amended as follows:

**SECTION 1**

Subsection 142-1, entitled “License fees for plenary retail consumption license and club license” shall be amended by deleting in its entirety Subsections A and B, and in their place and stead shall be the following:

**§142-1. License fees for plenary retail consumption license and club license.**

In compliance with N.J.S.A. 33:1-12, the yearly license fee for plenary retail consumption license from the effective date of this article shall be for the year 2017: \$2,120; and thereafter as follows: 2018: \$2,333; 2019: \$2,500. The license fees for club licenses shall be for the year 2017: \$63.

Subsection 142-5, entitled “Number of licenses issued” shall be amended by deleting same it in its entirety, and in its place and stead shall be the following:

**§142.5. Number of club licenses issued.**

There shall be issued and outstanding in the Township of Jefferson no more than three club licenses.

Subsection 142-10, entitled “Transfer application; fee” shall be amended by deleting same in its entirety.

**SECTION II**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

**SECTION III**

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.


**SECTION IV**

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
