## **ORDINANCE NO. 11-2023**

## MINOR AMENDMENTS TO ATTACHMENT 1 – AREA AND YARD REQUIREMENTS, CHAPTER 25, ADDRESSING LOT COVERAGE

**BE IT ORDAINED,** by the Municipal Council of the Township of Aberdeen, County of Monmouth and State of New Jersey, that Chapter 25, Attachment 1 entitled "Area and Yard Requirements" is hereby amended as follows:

NOTES:

(1) Single-story ranches in P.C. zone only may have twenty-five (25%) percent building coverage of principal building.

(2) A first story floor entry deck may be attached to the principal building in all residential zones. However, it may not be less than seven (7) feet to any property line in a R-50, R-60, PC and R-75 zone, except in a R-100 zone where it shall not be less than nine (9) feet to any property line, and in a RA zone where it shall not be less than fifteen (15) feet to any property line.

**BE IT FURTHER ORDAINED,** If any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

**BE IT FURTHER ORDAINED,** Any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

**BE IT FURTHER ORDAINED,** This Ordinance shall take effect upon passage and publication in accordance with applicable law.
