**LOCAL LAW NO. 2 OF 2020
REPEAL and REPLACEMENT
of Village of Alexandria Bay -
Chapter 60-10(C) - Enforcement, penalties for offense**

The existing Local Law shall be amended by the repeal of the identified provision and replacement as follows:

60-10. Enforcement, penalties for offense

C. A violation of §60-4, Private Watercraft, shall be punishable by a fine of \$200 per offense. A penalty sum of \$10 shall be added after 10 days unpaid, and an additional penalty sum of \$15 shall be added after 30 days unpaid.
