**ORDINANCE NO. 2018-01**

**AN ORDINANCE OF THE TOWNSHIP OF ALEPPO, ALLEGHENY COUNTY,  
PENNSYLVANIA, APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF A  
REVISED SANITARY SEWAGE TREATMENT AGREEMENT WITH THE BOROUGH OF  
SEWICKLEY FOR SANITARY SEWER SERVICES**

**WHEREAS**, the Borough of Sewickley and the Township of Aleppo entered into a Service Agreement on or about January 17, 2011, whereby the Borough of Sewickley agreed to provide sanitary sewage treatment services to the Township of Aleppo; and

**WHEREAS**, the Borough of Sewickley and the Township of Aleppo have determined that the continued provision of sanitary sewage treatment services by the Borough of Sewickley to the Township of Aleppo is in the mutual interest of both municipalities and will preserve the health, safety and welfare of both communities; and

**WHEREAS**, it is desired by the Borough of Sewickley and the Township of Aleppo to make certain modifications to their Service Agreement and to have an amended sanitary sewage treatment agreement setting forth the terms and conditions for continued provision of sanitary sewage treatment services by the Borough of Sewickley to the Township of Aleppo; and

**WHEREAS**, cooperation between the Borough of Sewickley and the Township of Aleppo in the exercise and performance of their governmental powers, duties and functions is authorized by various acts of the general assembly, including the Intergovernmental Cooperation Act, Act of December 19, 1966, P.L. 1158, No. 177 (53 Pa. C.S.A. §2301 et seq.), and

**WHEREAS**, the terms, conditions, duration, requirements, purposes and objectives of the agreement between the Borough of Sewickley and the Township of Aleppo for sanitary sewage treatment, including the powers and scope of authority delegated therein, are set forth in the revised Sanitary Sewage Treatment Agreement (the "Agreement"), a copy of which is attached to this Ordinance as an Exhibit and incorporated herein as if fully set forth at length.

**NOW, THEREFORE, BE IT ORDAINED and ENACTED** by the Township of Aleppo, Allegheny County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same as follows:

**Section 1** Pursuant to the Intergovernmental Cooperation Act, 53 Pa. C.S.A. §2301 et seq., the terms and conditions of the Amended Service Agreement by and between the Borough of Sewickley and the Township of Aleppo, a copy of which is attached hereto as Exhibit "A", are hereby ratified, approved and adopted.


Section 2 The execution of said Amended Service Agreement on behalf of the Township of Aleppo by the appropriate authorized officers of the Township of Aleppo is hereby authorized, ratified and approved.


Section 3 This Ordinance shall take effect immediately upon its adoption.
