

**ORDINANCE NO. 2024-11**

**AN ORDINANCE AMENDING CHAPTER 424, VEHICLES AND TRAFFIC, SECTION §424-5, THROUGH STREETS AND STOP INTERSECTIONS, OF THE VILLAGE OF ALLOUEZ MUNICIPAL CODE**

**SECTION 1. THE VILLAGE BOARD OF THE VILLAGE OF ALLOUEZ, BROWN COUNTY, WISCONSIN, DOES ORDAIN THAT SECTION §424-5, THROUGH STREETS AND STOP INTERSECTIONS, OF THE VILLAGE OF ALLOUEZ MUNICIPAL CODE BE AMENDED TO READ AS FOLLOWS:**

**§ 424-5. Through streets and stop intersections.**

The streets and intersections described in this section are hereby designated through streets and stop intersections as set forth herein. When stop signs are erected in accordance with this section, the operator of a vehicle approaching any such sign shall stop as required by law.

**A. Through streets.**

(1) North-south.

Baird Street/Libal Street, except at intersection of CTH O (Allouez Avenue) and CTH XX (Hoffman Road)

East River Drive, except at the intersection of CTH O (Allouez Avenue), Broadview Drive, Greene Avenue and CTH XX (Hoffman Road)

Riverside Drive, STH 57, except at the intersection of STH 172

Webster Avenue, except at the intersection of STH 172 and at the intersection of CTH O (Allouez Avenue), St. Joseph Street and Hoffman Road

(2) East-west.

Allouez Avenue, except at the intersection of Riverside Drive, Webster Avenue and Libal Street

Briar Lane (East and West), except at the intersection of Riverside Drive, Webster Avenue, Libal Street, Delahaut Street and East River Drive

Broadview Drive, except at the intersection of Webster Avenue, Libal Street and East River Drive

Dauphin Street, except at the intersection of Webster Avenue, Libal Street and East River Drive

Derby Lane, except at the intersection of Riverside Drive and Webster Avenue

Garland Street, except at the intersection of Webster Avenue and Baird Street

Greene Avenue, except at the intersection of Webster Avenue, Libal Street, Greenwald Street and East River Drive

Hoffman Road, except at the intersection of Webster Avenue and Libal Street

Kalb Avenue, except at the intersection of Webster Avenue and Libal Street

LeBrun Road, except at the intersection of Webster Avenue, Libal Street and East River Drive

Longview Avenue, except at the intersection of Webster Avenue, Delahaut Street, Libal Street and East River Drive

St. Joseph Street (East and West), except at the intersection of Webster Avenue, Libal Street and Riverside Drive

Taft Street, except at the intersection of Riverside Drive and Webster Avenue
