AN ORDINANCE

Amending the 2024 Fire Department budget to provide for a supplemental appropriation of Seven Hundred Seventy-Nine Thousand Two Hundred and Twenty-Eight Dollars (\$779,228.00) from Commonwealth of Pennsylvania, Department of Community and Economic Development Local Share Account grant for the purchase of a new fire truck.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2024 General Fund in the amount of Seven Hundred Seventy-Nine Thousand Two Hundred and Twenty-Eight Dollars (\$779,228.00).

This bill is originating from the Fire Department

- Summary and facts of the bill.

The purpose of this ordinance is to appropriate the revenue and expenses for the Commonwealth of Pennsylvania, Department of Community and Economic Development Local Share Account grant for the purchase of a new fire truck. The Fire Department was awarded \$779,228.00 to support the purchase of the new fire truck (pumper).
