THEREOF**

**WHEREAS**, the Township of Andover, in the County of Sussex, State of New Jersey (the "Township"), wishes to undertake various general capital improvements; and

**WHEREAS**, the cost of said improvements or purposes is estimated to be \$490,700; and

**WHEREAS**, the Township desires to authorize the appropriation and expenditure of \$490,700 from the General Capital Fund to undertake the improvements.

**BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF ANDOVER, IN THE COUNTY OF SUSSEX, STATE OF NEW JERSEY** (a majority of the full membership thereof affirmatively concurring), **AS FOLLOWS:**

**SECTION 1.** The capital improvements or purposes described below are hereby authorized as general capital improvements to be undertaken by the Township. For the said improvements or purposes, there is hereby appropriated the amount of \$490,700 from the General Capital Fund. The general capital improvements or purposes hereby authorized include, but are not limited to, (a) various renovations and improvements to Township buildings and grounds including, but not limited to Public Works garage floor replacement for \$29,500; (b) acquisition of various equipment for the Public Works Department including a fuel system for \$20,000, Jet Vac reconditioning for \$15,000, truck
