

ORDINANCE 2023-2

**AN ORDINANCE AMENDING
THE CITY OF ARCADIA
PARKS ORDINANCE**

The Common Council of the City of Arcadia, Wisconsin, do ordain as follows:

SECTION 1. Article I (title) of Chapter 280 of the City of Arcadia Code of Ordinances is amended to read as follows:

“CITY PARKS”

SECTION 2. Section 280-1 of the City of Arcadia Code of Ordinances is amended to add the following definitions:

“ASHLEY FOR THE ARTS – The celebration or festival sponsored by Ashley for the Arts, LTD. held on Thursday evening, Friday, Saturday and Sunday during the second weekend in August.”

“CITY PARKS – The parks available to the public and located on property owned by the City of Arcadia, including but not limited to Dettloff Park, Eugene Killian’s Children Park, Fairfield Park (a/k/a Tot Park), Vilas Hanson Park, Memorial Park, Pahl Park, Rudy Klink Deer Park, Schank Park, and Schultz Park.”

SECTION 3. The definition of “RECREATIONAL VEHICLE” or “RV” under Section 280-1 of the City of Arcadia Code of Ordinances is amended to read as follows:

“RECREATIONAL VEHICLE or RV – Shall have the meaning set forth in Wis. Stat. § 340.01(48r) ~~Wis. Stats.~~”

SECTION 4. Section 280-2 of the City of Arcadia Code of Ordinances is repealed and recreated to read as follows:

“280-2 Hours of Operation.

- A. Except as otherwise provided herein, the hours of operation of public parks in the City shall be 7:00 a.m. to 10:00 p.m., local time.
- B. Soldier’s Walk in Memorial Park shall be open from 7:00 a.m. to 10:00 p.m., local time.
- C. The Lions Pavilion shall be available for rental from 7:00 a.m. to 1:00 a.m., local time, except during Memorial Day weekend and during the second weekend of August of each year. The Lions Pavilion may be open from 7:00 a.m. to 2:00 a.m., local time, on Friday,

Saturday and Sunday of Memorial Day weekend and on Friday, Saturday, and Sunday of the second weekend of August each year.

D. All public parks in the City shall be closed to the public except during the hours of operation specified above.”

SECTION 5. Section 280-3 C. of the City of Arcadia Code of Ordinances is created to read as follows:

“C. During Ashley for the Arts no person other than Ashley for the Arts, LTD., shall bring into Memorial Park any alcohol beverages or wine. During Ashley for the Arts no person shall possess any alcohol beverages or wine in Memorial Park except for persons who have purchased the alcohol beverages or wine in their possession from Ashley for the Arts, LTD. concession stands located in Memorial Park. Notwithstanding anything contained herein to the contrary, the possession or sale of alcohol beverages or wine in Soldiers Walk is prohibited.”

SECTION 6. Section 280-4 (intro.) of the City of Arcadia Code of Ordinances is amended to read as follows:

“No person shall do or cause to be done by others to any shrubs or trees located in ~~Memorial Park~~ any of the City Parks any of the following acts:”

SECTION 7. Section 280-5 of the City of Arcadia Code of Ordinances is amended to read as follows:

“No person shall deface, injure, damage or destroy any public property located in ~~Memorial Park~~ any of the City Parks.”

SECTION 8. Section 280-6 of the City of Arcadia Code of Ordinances is amended to read as follows:

“No person shall park, stop or leave standing any vehicle, for any purpose, in ~~Memorial Park~~ any of the City Parks, except pursuant to a permit issued under §280-2A(6) and except in designated parking areas.”

SECTION 9. Section 280-7 B. of the City of Arcadia Code of Ordinances is amended to read as follows:

“B. No person shall operate or cause to be operated an ATV, UTV, or snowmobile within Memorial Park or any other City Park except on trails designated for such purpose by the Mayor or his or her designee. Citations issued under this subsection shall be issued to the registered owner of the vehicle unless the vehicle is not registered with the State of Wisconsin. If an ATV, UTV, or snowmobile is unregistered, the operator of the vehicle shall be issued a citation for any violation of this subsection.”

SECTION 10. Section 280-7 C. of the City of Arcadia Code of Ordinances is created to read as follows:

“C. There shall be no overnight parking of recreational vehicles or camping in any public park in the City, except pursuant to a special event permit issued by the City and a camping permit issued by Trempealeau County for camping in Memorial Park on Friday, Saturday, and Sunday of the second weekend of August each year.”

SECTION 11. This Ordinance #2023-2 shall take effect upon passage and publication as provided by law.
