ORDINANCE NO. 2024-3

ORDINANCE OF THE CITY OF ASBURY PARK AMENDING AND SUPPLEMENTING CERTAIN SECTIONS OF CHAPTER 5, ENTITLED “BEACH, BOARDWALK AND BEACHFRONT REGULATIONS,” OF “THE CODE OF THE CITY OF ASBURY PARK,” IN CERTAIN LIMITED RESPECTS

WHEREAS, the City of Asbury Park (the “City”) previously established Chapter 5, “Beach, Boardwalk and Beachfront Regulations,” of “The Code of the City of Asbury Park” (also referenced as the “City Code”); and

WHEREAS, the Mayor and Council wish to revise Chapter 5 of the City Code, relating to the beach daily and seasonal badge fees, in certain limited respects, in accordance with the provisions set forth herein.

NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED, by the Mayor and City Council of the City of Asbury Park, in the County of Monmouth and State of New Jersey, that Chapter 5, “Beach, Boardwalk and Beachfront Regulations,” of “The Code of the City of Asbury Park,” is hereby amended and supplemented in certain limited respects, as follows (additions are shown with underline; deletions are shown with ~~strikeout~~):

Chapter 5. Beach, Boardwalk and Beachfront Regulations

§ 5-1. DESIGNATION OF BEACH SEASON.

[2000 Code § 5-1; ~~New~~]

- a. For the protection of the general public and for the control of the beachfront of the City, the Mayor and Council shall by resolution each year designate a date for the opening of the beach season at the beachfront to the general public and residents of the City. The beach season shall commence and extend until a date set forth in the same resolution. In addition, ~~The~~ City shall adopt daily and seasonal beach pass fees as well as other rental fees by ~~ordinance as required by law~~ resolution on an annual basis.
- b. No person is permitted upon the beachfront of the City during the times that the beach season is in operation except upon payment of the fees established by the Mayor and Council for a daily or seasonal beach pass.
- c. By resolution the Mayor and Council shall designate the protected bathing beaches where ropes, buoys, boats and lifeguards are to be provided by the City, and from which beaches persons shall bathe, swim or surf.

§ 5-2.3. Seasonal Rates and Fees.

[2000 Code § 5-3.1;~~;~~**New**]

During the beach season there shall be a charge for all daily and a seasonal badges. Fees and hours and dates of operation of the beaches are set each year by ~~ordinance~~ resolution. A schedule of those fees and times are available at the office of the City Clerk.


BE IT FURTHER ORDAINED, that all other provisions of Chapter 5 of the City Code which are not referenced in this Ordinance shall remain unaffected/unchanged and remain in full force and effect.

BE IT FURTHER ORDAINED, that all parts and provisions of any Ordinance which are inconsistent with the provisions of this Ordinance shall be repealed to the extent of such inconsistency.

BE IT FURTHER ORDAINED, that the provisions of this Ordinance shall be severable. In the event that any portion of this Ordinance is found to be invalid for any reason by any Court of competent jurisdiction, such judgment shall be limited in its effect only to the portion of the Ordinance actually adjudged invalid and shall not be deemed to affect the operation of any other portion thereof, which shall remain in full force and effect.

BE IT FURTHER ORDAINED, that this Ordinance shall take effect upon final passage and publication in accordance with the law, following the required twenty (20) day period after adoption, as set forth in N.J.S.A. 40:69A-181(b).
