Council Member SHABAZZ Presents the following Ordinance:

ORDINANCE AMENDING CITY CODE CHAPTER 233 TAXICABS, JITNEYS AND VEHICLES FOR HIRE

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Atlantic City, County of Atlantic and State of New Jersey that Atlantic City Code Chapter 233-38 A “Specified Fares” shall be amended to increase the cash fare from \$2.50 to \$3.00 as follows:

SECTION 1: Chapter 233-38 A. shall be amended as follows:

On all authorized jitney routes there shall be charged a cash fare of ~~\$2.50~~ \$3.00, and there shall be established a frequent rider program, through which a book of 10 coupons may be purchased for \$20.00, one coupon being the value of one fare. Said coupons shall be made available at three centralized locations within the City of Atlantic City, said locations to be approved by the Director.

SECTION 2. Any ordinance or pars of any ordinance inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
