#### ATLANTIC COUNTY ORDINANCE NO. 1-2024

# AN ORDINANCE AMENDING COUNTY CODE CHAPTER 97 ENTITLED PARKS CONCERNING JOHN F. GAFFNEY GREEN TREE GOLF COURSE

**WHEREAS,** the County of Atlantic owns the John F. Gaffney Green Tree Golf Course ("Green Tree") which is part of the Atlantic County Park system, and which is managed by the Atlantic County Improvement Authority (the "Authority") as a public golf course; and

WHEREAS, to offset rising costs of employee salaries, goods, and services a small increase in membership fees, as well as to certain greens and league fees will allow the County to provide the same level amenities to which Atlantic County residents and visitors have been accustomed at Green Tree Golf Course; and

**WHEREAS,** in order to effectuate the changes, it is necessary to change certain provisions in Atlantic County Code Chapter 97, specifically sections 97-118, 97-119, and 97-120 for the 2024 calendar year commencing on March 1, 2024;

**NOW, THEREFORE, BE IT ORDAINED** by the Atlantic County board of County Commissioners as follows:

- 1. Section 97-118, Sub-section titled "Fees".
- 2. The annual fee for an initial application and ID Card is \$22.00 shall be changed to read the annual fee for an initial County resident membership is \$25.00.
- 3. The fee for an annual renewal is \$18.00 shall be changed to read as follows: "The fee for an annual renewal is \$20.00".

Section 97-120 Greens Fees, sections A, B, and C, last amended by Ord. No. 1-2023, are hereby changed to the proposed new fees which are listed in parentheses:

All terms, provisions and requirements of the Atlantic County Code Chapter 97 not specifically amended by or inconsistent with the terms of this ordinance shall remain in full force and effect.

#### 4. Construction

This Ordinance shall be liberally construed for its intended purposes.

If any section or subjection, paragraph, sentence, clause or phrase or word contained in this Ordinance is declared invalid for any reason whatsoever, such a decision shall not affect the remaining portions of this ordinance, which shall remain in full force and effect.

## 5. Repealer

Any Ordinance or portion thereof enacted by the Conty that pertain to any subject matter governed by this Ordinance, which is inconsistent with, or which stands as an obstacle to the effective implementation of this Ordinance shall be superseded by the Ordinance and is hereby repealed and set aside.

#### 6. Effective Date

This Ordinance will take effect following passage and publication in accordance with law.
