

ATLANTIC COUNTY ORDINANCE NO. 6 - 2024

**AN ORDINANCE REVISING SPEED LIMITS
ALONG OLD NEW YORK ROAD (CR 575/610)
IN THE CITY OF PORT REPUBLIC AND TOWNSHIP OF GALLOWAY**

WHEREAS, Old New York Road (County Routes 575/610) is a County Road, and

WHEREAS, speed limits have been previously established on Old New York Road (County Routes 575/610) in the City of Port Republic and Township of Galloway by Ordinance No. 29 - 1987 of the Board of Chosen Freeholders of the County of Atlantic, passed and adopted on December 1, 1987, as follows:

Zone 1. 50 MPH - U.S. Route 9 to Riverside Drive

Zone 2. 35 MPH - Riverside Drive to Adams Avenue

Zone 3. 45 MPH - Adams Avenue to Chestnut Neck Road (CR 575/650)

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the County of Atlantic, that:

SECTION 1: The speed limits for both directions of traffic along Old New York Road (County Routes 575/610) in the City of Port Republic and Township of Galloway, be established as follows:

Zone 1. 45 MPH - U.S. Route 9 to Riverside Drive

Zone 2. 35 MPH - Riverside Drive to Adams Avenue

Zone 3. 45 MPH - Adams Avenue to Chestnut Neck Road (CR 575/650)

SECTION 2: Regulatory and warning signs shall be erected and maintained to effect the above-designated speed limits.

SECTION 3: This ordinance shall take effect twenty (20) days after final passage and publication as required by law.

SECTION 4: The Clerk of the Board of Commissioners shall send a certified copy of the adopted ordinance to the Atlantic County Engineer, and to the Clerks of the affected municipalities.

SECTION 5: All previous ordinances and resolutions, or parts of ordinances and resolutions, inconsistent with the terms and provisions of this ordinance, are hereby repealed to the extent of such inconsistencies.

SECTION 6: The penalty for violation of any provision of this ordinance shall be that specified in N.J.S.A. 39:4-104 and any amendments thereto.
