ORDINANCE NO. 1400

AN ORDINANCE OF THE BOROUGH OF AVALON, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 385 ("VEHICLES AND TRAFFIC"), ARTICLE II ("TRAFFIC REGULATIONS") OF THE CODIFIED ORDINANCES OF THE BOROUGH OF AVALON WITH REGARD TO DESIGNATE ONE-WAY STREETS AND AUTHORIZING VARIOUS ONE-WAY STREETS AND THE PLACEMENT OF STOP SIGNS AND AUTHORIZING THE INSTALLATION OF ADDITIONAL STOP SIGNS AT VARIOUS INTERSECTIONS IN THE BOROUGH OF AVALON.

WHEREAS, Chapter 61 of the Pennsylvania Vehicle Code, 75 PA C.S. §§ 6101 et seq., grants authority to local municipalities to ordain reasonable rules and regulations for the control of the movements of motor vehicle traffic; and

WHEREAS, the Pennsylvania Vehicle Code, particularly Sections 67 PA C.S. §§ 212.113, gives local municipalities the authority to establish a one-way street provided traffic flow, terminal points and emergency vehicles access conditions are satisfied; and

WHEREAS, the Pennsylvania Vehicle Code, particularly Sections 75 PA C.S. §§ 6109 and 6124, gives local municipalities the authority to erect and maintain stop signs and designate an intersection and junction of roadways as stop or yield intersections or junctions; and

WHEREAS, the Council of the Borough of Avalon finds that certain amendments to its traffic regulations in Chapter 385 ("Vehicles and Traffic"), Article II ("Traffic Regulations") of the codified ordinances of the Borough of Avalon, are necessary to promote convenient and safe movement of motor vehicles within and through the Borough of Avalon and to adequately protect both the safety and welfare of Borough residents as well as those traveling within the Borough of Avalon; and

NOW, THEREFORE, The Council of the Borough of Avalon, pursuant to the authority of Chapter 61 of the Pennsylvania Vehicle Code, 75 PA C.S. §§ 6101 et seq., and Chapter 385-2 of the Codified Ordinances of the Borough, hereby **ORDAINS** as follows:

Section 1. Section 385-12 of the Codified Ordinances of the Borough of Avalon is hereby amended the direction of travel at the following location:

Section 2. Section 385-15 of the Codified Ordinances of the Borough of Avalon is hereby amended to add a stop sign at the following locations:

Section 4. All the remaining provisions of Article II, Chapter 385 ("Traffic Regulations"), of the Codified Ordinances of the Borough of Avalon which are not specifically amended herein shall remain in full force and effect. All ordinances (or parts of ordinances) currently in existence are repealed to the extent that such ordinances are inconsistent with the provisions of this Ordinance.				
Section 5. The provisions of this Ordinance are severable. If any section, sentence or clause of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining sections, sentences or clauses of this Ordinance.				
Section 6. This Ordinance shall become effective upon enactment by Council of the Borough of Avalon.
