**AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT,

- B. The following schedule of fees is hereby fixed, determined, and established as being the fees to be paid to the municipality for the issuance of permits in connection with the servicing of permits and supervision and inspection of openings and drainages to the proper restoration.

Openings up to 50 square feet in length \$200.00.

Openings over 50 square feet but less than 500 square feet \$250.00.

Openings over 500 square feet but less than 1,500 square feet \$300.00

Openings over 1,500 square feet \$350.00.

Such fees shall accompany the application when filed with the Construction Official or other designated agent.

If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect or invalidate the remainder of this Ordinance but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.
