ORDINANCE 2023-02

AN ORDINANCE OF THE BOROUGH OF BAY HEAD, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 147 OF THE BOROUGH CODE OF THE BOROUGH OF BAY HEAD, ENTITLED "LAND USE"

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Borough of

Bay Head, County of Ocean, State of New Jersey, as follows:

SECTION 1. The Borough Code of the Borough of Bay Head is hereby amended and

supplemented so as to amend Chapter 147, entitled "Land Use" so as to amend §147-6 entitled

"General provisions," so as to add a new subsection Q. which shall read as follows:

Q. Dumpsters and temporary storage.

(1) When a dumpster or temporary storage container is used, a permit shall be required.

(2) Dumpsters shall be permitted for up to one year per location.

(3) Temporary storage containers or short-term dumpsters are permitted for up to seven days.

(4) Permit fees are set forth in Article XVI of this Chapter.

SECTION 2. The Borough Code of the Borough of Bay Head is hereby amended and supplemented so as to amend Chapter 147, entitled "Land Use" so as to create Article XVI which shall be entitled "Zoning Fees" and which shall read as follows:
