THE 2023 TAX LEVY ORDINANCE OF
VILLAGE OF BANNOCKBURN, LAKE COUNTY, ILLINOIS FOR THE FISCAL
YEAR BEGINNING MAY 1, 2023 AND ENDING APRIL 30, 2024

WHEREAS, the Village Board of Trustees approved the Budget for the fiscal year beginning May 1, 2023 and ending April 30, 2024; and

WHEREAS, the Village Board of Trustees properly considered the amounts of money to be raised through ad valorem property taxes on October 10, 2023 and has considered the 2023 Tax Levy.

NOW THEREFORE, be it Resolved by the President and Board of Trustees of the Village of Bannockburn (Village), Lake County, Illinois as follows:

SECTION ONE: That the following sums of money, or as much thereof as may be authorized by law, are deemed necessary to defray all necessary expenses and liabilities of the VILLAGE OF BANNOCKBURN for the fiscal year beginning May 1, 2023 and ending April 30, 2024, and said sums are hereby levied against all taxable property in the VILLAGE for the objects and purposes herein specified, viz:

SECTION TWO: That the extended balances of any item or items levied in and by this Ordinance may be guaranteed in making up any deficiency in any items under the same general appropriation and levy for the same general purpose.

SECTION THREE: That the following is a summary of the taxes hereinabove levied:

| Category | Levy Amount | Budgeted Amount |
|------------------------------------|------------------|---------------------|
| Audit Tax | \$ 32,293 | \$ 36,300 |
| Street & Bridge | \$ 86,966 | \$ 933,326 |
| Police Protection/System | \$798,952 | \$ 1,893,817 |
| Tort/Judgement/Liability Insurance | \$ 64,326 | \$ 79,994 |
| Total | <u>\$958,531</u> | <u>\$ 2,943,437</u> |

SECTION FOUR: That the Village Clerk is hereby directed to file with the County Clerk of Lake County, Illinois, on or before the 26th day of December, 2023 a copy of this Ordinance duly certified by said Village Clerk.

SECTION FIVE: That if any provision of this Ordinance is held unconstitutional, invalid, or unenforceable, then that provision will be deemed severed and the remainder of this Ordinance shall remain in full force and effect.

SECTION SIX: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form in the manner provided by law.




