WHEREAS, the Village of Bannockburn did establish Village of Bannockburn Special Service Area Number Seventeen ("SSA #17") pursuant to Village of Bannockburn Ordinance No. 2011-19 (the "Establishing Ordinance"); and

WHEREAS, the corporate authorities of the Village of Bannockburn serve as the governing body of SSA #17; and

WHEREAS, consistent with the terms of Section 5.B of the Establishing Ordinance, the President and Board of Trustees have determined that it is necessary, appropriate, and in the best interests of the Village and its residents to levy and extend taxes upon real property in SSA #17, as set forth in this Ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BANNOCKBURN, LAKE COUNTY, ILLINOIS:

SECTION ONE: **Tax Levy.**

Pursuant to the Establishing Ordinance, the Village hereby levies \$18,471 in taxes for the fiscal year beginning May 1, 2023 and ending April 30, 2024, against the real property within SSA #17 in accordance with the Special Tax Roll as follows:

16-18-400-019 and -020 (2560 Telegraph Road)	\$6,157.00
16-18-400-016 (2580 Telegraph Road)	\$6,157.00

SECTION TWO: That the Village Clerk is hereby directed to file with the County Clerk of Lake County, Illinois, on or before the 26th day of December, 2023 a copy of this Ordinance duly certified by said Village Clerk.

SECTION THREE: That if any provision of this Ordinance is held unconstitutional, invalid, or unenforceable, then that provision will be deemed severed and the remainder of this Ordinance shall remain in full force and effect.

SECTION FOUR: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form in the manner provided by law.




