# AN ORDINANCE AMENDING ARTICLE VIII OF CHAPTER 141 OF THE VILLAGE CODE REGARDING DOG LICENSING

WHEREAS, the Village of Bannockburn (the "Village") is an Illinois home rule municipality operating under Article VII, Section 6 of the Illinois Constitution and the Illinois Municipal Code, 65 ILCS 5; and

WHEREAS, Article VIII of Chapter 141 of the Bannockburn Village Code (the "Village Code") sets forth various conditions and provisions relating to the licensing of dogs; and

WHEREAS, the President and Board of Trustees of the Village (the "Village Board") have determined that it will serve and be in the best interests of the Village and its residents to amend various provisions of Article VIII of Chapter 141 of the Village Code to improve the efficiency and convenience of dog licensing in the Village;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Bannockburn, County of Lake, State of Illinois, as follows:

**SECTION ONE**. Recitals. The foregoing recitals are incorporated into and made a part of this Ordinance by reference.

SECTION TWO. Amendments to Article VIII of Chapter 141 of the Village Code.

Article VIII, entitled "Dogs," of Chapter 20, of Chapter 141, entitled "General Offenses," of the Village Code is hereby amended as follows:

A. The definition of "License Year" in Section 141-801 of the Village Code is hereby amended in its entirety, so that such definition shall hereafter be and read as follows:

### LICENSE YEAR

January 1 of each year through December 31 of the same year or such other period as may be established as part of the fee ordinance or other approval of the Village Board.

B. Subsection 141-802.B of the Village Code is hereby amended in its entirety, so that such subsection shall hereafter be and read as follows:

Application. Written application for a license shall be made annually by the owner at the beginning of each license year. The application shall include evidence that all required permits, licenses, and approvals have been obtained from the Lake County Health Department. In addition, the application for a license under this section shall contain:

- 1. The name and address of the owner of the dog to be licensed;
- 2. The breed, color, gender, age, and name of the dog to be licensed;
- 3. The date of inoculation against rabies of the dog to be licensed;
- 4. Payment of the license fee required by Subsection C of this section;
- 5. Whether the dog to be licensed is spayed or neutered; and
- 6. Any other information as may reasonably be requested on the application form to be prepared by the Village Manager.

To the extent that the Village Manager promulgates application forms that modify the foregoing requirements, such modified forms shall control.


- C. A new Subsection 141-802.G of the Village Code is hereby adopted, which new subsection shall hereafter be and read as follows:
  - G. <u>Alternative Procedures</u>. To the extent alternative procedures to those otherwise set forth in this Section 141-802 are adopted as part of another Village ordinance, such alternative procedures shall apply notwithstanding the provisions of this Section.

**SECTION THREE**. **Effective Date**. This Ordinance shall be in full force and effect upon its passage, approval, and publication in the manner provided by law.
