

AN ORDINANCE ACCEPTING SUPPLEMENTAL AGREEMENT FOR COST APPORTIONMENT BETWEEN THE LOCAL AGENCY KNOWN AS MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION AND THE CITY OF BATTLEFIELD, MISSOURI AND AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE THE CONTRACT FOR SU0189, SU0210 2024-04-83958 FOR PUBLIC IMPROVEMENTS ON ROUTE FF AT WEAVER ROAD AND ROADWAY SIDEWALK IMPROVEMENTS ON WEAVER ROAD.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BATTLEFIELD, MISSOURI as follows:

WHEREAS, the City of Battlefield desires public improvements generally consisting of sidewalk along Route FF and Weaver Road for the design of intersection improvements on Route FF at Weaver Road and sidewalk improvements on Weaver Road including, but not limited to, the engineering, design, bidding, and construction phase of sidewalk improvements within the City limits, (the "Project") through City Funds Agreement; and

WHEREAS, the stipulations of said agreement are attached; and


WHEREAS, the Board of Aldermen desire to enter such an agreement with the Missouri Highways and Transportation Commission.

NOW, THEREFORE, BE IT ORDAINED by the Board of Aldermen of the City of Battlefield, Missouri as follows:

Section 1. The Board of Alderman hereby accepts the terms of the agreement and authorizes the City Administrator and/or Mayor to execute the contract in the form attached as Exhibit "1".

Section 2. This Ordinance shall be in full force and effect upon and after its passage and approval.


