**ORDINANCE NO. 8-14-23B**

**AN ORDINANCE OF THE MUNICIPALITY OF BETHEL PARK, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 65, ARTICLE IX, SECTION 65.26, SUBSECTION 65.26.1, OF ORDINANCE NO. 7-12-93A (THE CODE OF THE MUNICIPALITY OF BETHEL PARK), TO INDICATE THAT WHEN TRAVELLING IN THE WESTERLY DIRECTION ON MCANULTY ROAD LEFT HAND TURNS ARE PROHIBITED ONTO HORNING ROAD AND WHEN TRAVELLING IN THE WESTERLY DIRECTION ON HORNING ROAD, RIGHT HAND TURNS ARE PROHIBITED ONTO MCANULTY ROAD**

**WHEREAS**, Chapter 65, Article IX, Section 65.26, Subsection 65.26.1 of the Municipality of Bethel Park Code prohibits left and right turns in certain locations within the Municipality, as indicated; and

**WHEREAS**, it has come to the attention of the Council of the Municipality of Bethel Park that, due to the current configuration of the roadways and traffic flow, it is advisable to prohibit left hand turns from McAnulty Road onto Horning Road and right hand turns from Horning Road onto McAnulty Road; and

**WHEREAS**, in order to promote the health, safety and welfare of its residents, the Council of the Municipality has determined that the Bethel Park Code shall be amended to prohibit left hand turns by motorists traveling in a westerly direction on McAnulty Road and turning onto Horning Road and to prohibit right hand turns by motorists traveling in a westerly direction on Horning Road and turning onto McAnulty Road.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED**, by and with the Council of the Municipality of Bethel Park, in meeting assembled, and it is hereby ordained and enacted by and with the authority of the same as follows:

**SECTION 1.** THAT Municipality of Bethel Park Code Article IX - Stop Intersections, Section 65.26.1, shall be amended to include language prohibiting left hand turns from McAnulty Road onto Horning Road, and shall state as follows:

**No left turn when travelling in the westerly direction along McAnulty Road  
and turning onto Horning Road**

**SECTION 2.** THAT Municipality of Bethel Park Code Article IX - Stop Intersections, Section 65.26.1, shall be amended to include language prohibiting right hand turns from Horning

Road onto McAnulty Road, and shall state as follows:

**No right turn when travelling in the westerly direction along Horning Road and turning onto McAnulty Road**

**SECTION 3.** THAT the Manager of the Municipality of Bethel Park, or designee, is hereby authorized to install any relevant signage to describe the prohibit turning in accordance with this Ordinance.


**SECTION 4:** THAT the provisions of this Ordinance are declared to be severable, and if any section, sentence, clause or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses and phrases of the Ordinance, but they shall stand notwithstanding the invalidity of any part.


**SECTION 5:** THAT this Ordinance shall be effective thirty (30) days from adoption, in accordance with Article 11, section 1107 of the Bethel Park Home Rule Charter.

**SECTION 6.** THAT any Ordinance or part of Ordinance conflicting with the provisions of this Ordinance be and the same is hereby repealed to the extent of such conflict.
