ORDINANCE NO. 9-9-24C

AN ORDINANCE OF THE MUNICIPALITY OF BETHEL PARK, ALLEGHENY COUNTY, COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 65 ("VEHICLE AND TRAFFIC"), ARTICLE X ("PARKING PROHIBITIONS"), SECTION 65.29 ("PARKING PROHIBITED DURING CERTAIN HOURS") OF THE CODE OF THE MUNICIPALITY OF BETHEL PARK TO PROHIBIT PARKING ON THE NORTHERLY SIDE OF JORDAN DRIVE BETWEEN BROUGHTON ROAD AND ORCHARD PARK ROAD; AND TO PROHIBIT PARKING ON THE SOUTHERLY SIDE OF JORDAN DRIVE FOR A DISTANCE OF 50 FEET FROM THE INTERSECTION OF JORDAN DRIVE AND BROUGHTON ROAD

WHEREAS, the Municipality of Bethel Park has adopted ordinances, codified at Chapter 65 ("Vehicle and Traffic"), regulating parking within the Municipality; and

WHEREAS, the Municipality of Bethel Park, pursuant to Chapter 65, ("Vehicle and Traffic") Article X ("Parking Prohibitions"), Section 65.29 ("Parking Prohibited During Certain Hours"), has prohibited parking at certain locations within the Municipality; and

WHEREAS, the Council of the Municipality of Bethel Park has determined that it will promote the health, safety, and welfare of the residents of and visitors to the Municipality of Bethel Park if parking shall be prohibited on the northerly side of Jordan Drive between Broughton Road and Orchard Park Road; and

WHEREAS, the Council of the Municipality of Bethel Park has determined that it will promote the health, safety and welfare of the residents of and visitors to the Municipality of Bethel Park if parking shall be prohibited on the southerly side of Jordan Drive for a distance of 50 feet from the intersection of Jordan Drive and Broughton Road.

NOW THEREFORE, be it ORDAINED and ENACTED, by the Council of the Municipality of Bethel Park, as follows:

Section 1.

The Code of the Municipality of Bethel Park at Chapter 65 ("Vehicle and Traffic"), Article X ("Parking Prohibitions"), Section 65.29 ("Parking prohibited during certain hours"), Subsection 65.29.1 is hereby amended by adding the following subsections 65.29.1(75) and 65.29.1(76) as follows:

65.29. Parking prohibited during certain hours.

65.29.1. It shall be unlawful for the operator of any vehicle to park the same on any of the streets or parts of streets designated in this section during the hours specified. When no hours are specified, parking is prohibited at any time. Signs shall be erected and maintained in each block designating the provisions of this section.

- 75. On the northerly side of Jordan Drive between Broughton Road and Orchard Park Road
- 76. On the southerly side of Jordan Drive for a distance of 50 feet from the intersection of Jordan Drive and Broughton Road.

Section 2.

The Manager or designee is hereby directed to erect official sign(s) prohibiting parking pursuant to this Ordinance.

Section 3.

All ordinances or resolutions or parts of ordinances or resolutions in conflict with the terms of this Ordinance are repealed and rescinded to the extent that such conflict exists.

Section 4.

This Ordinance shall become effective 30 days from the date of adoption.
