AN ORDINANCE OF THE BOROUGH OF BEACHWOOD, OCEAN COUNTY, NEW JERSEY AMENDING CHAPTER XV ENTITLED "WATER" OF THE BOROUGH CODE TO AFFECT WATER RATES FOR THE YEARS 2023 AND 2024

BE IT ORDAINED by the Borough Council of the Borough of Beachwood, County of Ocean and State of New Jersey, as

follows:

Section 15-1.9 entitled, "Rates and Charges" is hereby amended to delete subsections SECTION 1 -

15-1.9 a. and b. and to insert in their place and stead the following:

"15-1.9 Rates and Charges.

a. Minimum charge shall be:

b. A minimum charge as stated in Paragraph a. of this subsection shall be the charge for consumption or use of the first seven thousand (7,000) gallons or less per quarterly period. Thereafter, the additional charge shall be \$7.60 for the year 2023; and \$8.40 for the year 2024 for every one thousand (1,000) gallons used over and above the 7,000 gallon minimum.

SECTION 2. This Ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.

SECTION 3. This Ordinance shall be effective upon public hearing and adoption as of July 19, 2023.
