ORDINANCE #2024-6C

AN ORDINANCE AMENDING Chapter 184, "Tennis Courts, Municipal" and Chapter 145, "Pickleball Courts, Municipal" in the Borough Code of the Borough of Beach Haven, County of Ocean, State of New Jersey

PURPOSE

The purpose of this Ordinance is to increase fees for daily passes and non-resident passes while decreasing fees for resident passes.

NOW THEREFORE, THE MAYOR AND COUNCIL OF THE BOROUGH OF BEACH HAVEN DO ORDAIN:

SECTION I

Section 184-2 "Fees for Passes" shall be amended as follows (underscores represent additions; ~~strikethroughs~~ represent deletions):

A. Passes for the purposes stated in § ~~184-1~~ hereby will be issued by the Municipal Clerk or his/her designee in accordance with the following fee schedule:

- (1) Daily pass: \$7 \$10 per person.
- (2) Weekly or any fractional part thereof: \$30 per person.
- (3) Resident season pass: ~~\$90~~ \$80 per person.
- (4) Nonresident season pass: ~~\$110~~ \$120 per person. Proof of residence shall be provided by New Jersey driver's license, tax, water, or sewer bill, or twelve-month lease, and may include any dependents residing in the home. The Borough Manager may approve other proof of residence on a case-by-case basis.

~~B. Tennis lessons will be available at the public courts with a Borough-employed tennis pro at the following rates:~~

- ~~(1) Individual: \$60 per hour.~~
- ~~(2) More than one individual: \$80 per hour.~~

SECTION II

Section 145-2 "Fees for Passes" shall be amended as follows (underscores represent additions; ~~strikethroughs~~ represent deletions):

A. Passes for the purposes stated in § ~~145-1~~ hereby will be issued by the Borough Clerk or his or her designee in accordance with the following fee schedule:

- (1) Daily pass: \$7 \$10 per person.
- (2) Weekly pass: \$30 per person.
- (3) Resident season pass: ~~\$90~~ \$80 per person.
Proof of residence shall be provided by a NJ driver's license, tax, water, sewer bill, or 12-month lease, and may include any dependents residing in the home. The Borough Manager may approve other proof of residence on a case-by-case basis.
- (4) Nonresident season pass: ~~\$110~~ \$120 per person.
Proof of residence shall be provided by New Jersey driver's license, tax, water, or sewer bill, or twelve-month lease, and may include any dependents residing in the home. The Borough Manager may approve other proof of residence on a case-by-case basis.

SECTION III

All Ordinances or parts of Ordinances inconsistent herewith are repealed to the extent of such inconsistency. The Clerk of the Borough is authorized to renumber and/or re-codify any sections affected by such repeal to the extent consistent with this Ordinance.

SECTION IV

If any word, phrase, clause, sections, or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.


SECTION V

This Ordinance shall take effect upon publication thereof after final passage according to law.


CERTIFICATION
