

ORDINANCE #2026-6C

AN ORDINANCE AMENDING Chapter 184, Tennis Courts, Municipal, of the Borough Code of the Borough of Beach Haven, County of Ocean, State of New Jersey, 2000,”

PURPOSE

The purpose of this ordinance is to prohibit pickleball play at the facility.

NOW THEREFORE, THE MAYOR AND COUNCIL OF THE BOROUGH OF BEACH HAVEN DO ORDAIN:

SECTION I

Chapter 184, Section 1 “**Use of facilities limited; pass required**” shall be amended as follows: (underscores represent additions; ~~strikethroughs~~ represent deletions):

§ 184-1. **Use of facilities limited; pass required.**

- A. The facilities of the Borough-owned tennis courts situated and located at the southwest corner of Bay Avenue at Pearl Street shall be limited to individuals purchasing official passes for the current season issued by the Borough Clerk or his or her designee, during hours that an attendant is present.
- B. Pickleball play is strictly prohibited on any of the designated courts within this facility. All individuals using designated municipal court facilities within the park are to follow the rules and regulations of the park at all times.

SECTION II

All Ordinances or parts of Ordinances inconsistent herewith are repealed to the extent of such inconsistency. The Clerk of the Borough is authorized to renumber and/or re-codify any sections affected by such repeal to the extent consistent with this Ordinance.

SECTION III

If any word, phrase, clause, sections, or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.


SECTION IV

This Ordinance shall take effect upon publication thereof after final passage according to law.
