## AN ORDINANCE TO AMEND CHAPTER 530 OF THE BETHANY BEACH CODE TO ADDRESS OPEN FOR BUSINESS SIGNS

**WHEREAS**, the Town Council of the Town of Bethany Beach desires to amend Chapter 530 of the Town Code to address Open For Business Signs within the Town of Bethany Beach.

WHEREAS, the proposed amendments contemplated by this ordinance are in the best interest of the Town.

**BE IT HEREBY ENACTED** by the Town Council of the Town of Bethany Beach, a majority thereof concurring in Council duly met that the Town Code be and hereby is amended as follows:

Section 1. Amend §530-3 Definitions (Additions are highlighted in bold below):

## **OPEN FOR BUSINESS SIGN**

A Banner or flag sign of lightweight fabric or similar material displaying the word "OPEN." The Banner or flag also may display the business name, business logo and/or a description of the business. Any such Banner or flag must and-be limited in size to 27" x 40", or 7.5 square feet that is either hung on a building or suspended as a flag, that does not impede pedestrian traffic or line of sight, to be used only during business hours. The Banner or flag must be attached to the storefront in which the business is located.

- **Section 2.** Amend Section §530-4 Exempt Signs (Additions are highlighted in bold below):
  - M. Open for Business signs limited to one per business as defined herein.
- **Section 3.** Amend §530-5(B) Prohibited signs and devices (Additions are highlighted in bold below):

## (4) Exempt banner signs

- **Section 4.** Amend §530-12 Permitted signs in the C-1, C-2 and CL-1 Districts (Amendments are highlighted in bold below):
- F. Windblown displays, including but not limited to any banner, pennant, gas balloon or flag that is designed to inform or attract attention are prohibited (except for exempt flags **and open for business signs as defined**). However, temporary event signs, pennants, flags and banners that are used in conjunction with commercial and noncommercial events as well as in-store special sales events may be permitted, but only
