1	Andrew Bayne Memorial Library; Ellen Goodman, Director Ms. Goodman noted that she did not have much to report, and it would be covered under “New Business”.	
2	Bellevue Parks; Bryan Churilla, HRG Engineer & Jim Kelly, DPW Superintendent - Mr. Churilla reported that a grant application to provide lights at the Dek Hockey rink and re-surface the tennis courts has been submitted. - Mr. Kelly added that a tree fell on the tennis court fence; DPW will try to repair this.	
Unfinished Business:		
1	External Library Repairs - Mr. Kelly reported that he has not received any more quotes; the Carmel quote for \$45,450 to complete all exterior work is the only one he has. This will be added to the agenda for the Pre-Council meeting for discussion in anticipation of issuing a formal bid. - He also noted that a tree fell at the library and there was no power for 2 days.	
2	Waterline to Dog Park Mr. Kelly stated that this will take about 3-4 days once DPW is able to start.	
New Business:		
1	Concerts at Bayne Park Ms. Goodman has booked 3 bands, and they are scheduled for the 3rd Wednesday of June, July, and August. Each band costs about \$600. The first concert will be June 16. This will be added to the agenda for the June Pre-Council meeting.	

2	Library Staffing ▪ Ms. Goodman reported that the state is re-opening, so the library should as well. She would like to create a new position, “Coordinator of Children & Youth Services” and has a few candidates in mind. She has developed a job description which will be provided to both the Parks & Recreation and Finance Committees, and this will be added to the June Pre-Council meeting agenda.
