**AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF BERKELEY, MISSOURI, TO EXECUTE THE DEED AND ACKNOWLEDGE OTHER DOCUMENTS IN ORDER FOR THE REAL PROPERTIES TO BE TRANSFERRED TO THE CITY FOR CITY DEVELOPMENT AND/OR BEAUTIFICATION**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY, MISSOURI, AS FOLLOWS:**

**Section 1.** The Mayor of the City of Berkeley, Missouri, is hereby authorized to execute the deed acknowledgement and any other documents necessary to effectuate the transfer of the following properties to the City from the Trustee of St. Louis County for City development and/or beautification:


**Section 3.** The City of Berkeley, Missouri, will receive a Trustee's Deed from St. Louis County deeding the subject property to the City of Berkeley.
