
NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY, MISSOURI, AS FOLLOWS:

- Section 1.** The City Manager is hereby authorized to execute a change order #1 Agreement for tree removal services with Mauldin Mountain Enterprises LLC dba Mockingbird Tree.
- Section 2.** The agreement is attached and hereby incorporated herein and made a part of this ordinance, as if fully set out herein.
- Section 3.** This Ordinance shall be in full force and effect from and after its date of passage.
- Section 4.** The City does hereby find and declare that an emergency exists which requires the immediate passage of this ordinance for the preservation of the welfare of the citizens of the City of Berkeley.



The parties agree to amend the contract to delete" PROJECT COSTS NOT TO EXCEED \$100,000" AND REPLACE WITH" PROJECT COST NOT TO EXCEED \$300,000." As stated in the BID DOCUMENTS on page 21, PAYMENT WILL BE MADE ON ACTUAL QUANTITIES.

PROPOSAL FOR ADDITIONAL TREE WORK IN BERKELEY

Nathan and Keith,

We are requesting an increase in \$200,000 dollars for the budget in our tree contract with Berkeley. I am attaching a spreadsheet for our recommendations for tree removals in 2 phases:

1) Immediate hazards and dead trees	\$75,000
2) Future hazards and decaying trees	\$65,000
3) Spring cleanup city wide pruning	\$20,000
4) Home owner Matching program	\$20,000
5) Unexpected expenses	\$20,000
TOTAL	\$200,000

I believe this will more than cover the tree care needs of the city for the next year.
