**AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES OF THE
TOWNSHIP OF BELLEVILLE, NEW JERSEY, CHAPTER 8-16, ENTITLED
HANDICAPPED PARKING SPACES**

Section I: that section 8, schedule 16 of the entitled ordinance is hereby amended by ADDING the following locations to be designated as a restricted parking space for use by the person who has been issued an identification card or special handicapped plates by the Division of Motor Vehicles. The following locations will expire one year after installation, pending re-evaluation of handicapped parking space request and confirmation of necessary credentials.

<u>STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
14 Chestnut Street	North	Beginning at a point 158' west of the N/W apex of Chestnut Street / Passaic Avenue and continuing to a point 22' west thereof;
124 Bell Street	East	Beginning at a point 170' north of the N/E apex of Bell Street / Greylock Parkway and continuing to a point 22' north thereof;
55 Van Houten Place	East	Beginning at a point 25' south of the S/E apex of Van Houten Place / Hornblower Avenue and continuing to a point 22' south thereof;
94 Heckel Street	East	Beginning at a point 33' south of the S/E apex of Heckel Street / Jeraldo Street and continuing to a point 22' south thereof;
15 Walnut Avenue	West	Beginning at a point 158' north of the N/W apex of Walnut Street / Belleville Avenue and continuing to a point 22' north thereof;

<u>STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
217 Greylock Parkway	South	Beginning at a point 50' west of the S/W apex of Greylock Parkway / Beech Street and continuing to a point 22' west thereof;
101 Tappan Avenue	South	Beginning at a point 214' east of the S/E apex of Tappan Avenue / Dewitt Avenue and continuing to a point 22' east thereof.






