**AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES OF THE
TOWNSHIP OF BELLEVILLE, NEW JERSEY, CHAPTER 8-16, ENTITLED
HANDICAPPED PARKING SPACES**

Section I: that section 8, schedule 16 of the entitled ordinance is hereby amended by ADDING the following locations to be designated as a restricted parking space for use by the person who has been issued an identification card or special handicapped plates by the Division of Motor Vehicles. The following locations will expire one year after installation, pending re-evaluation of handicapped parking space request and confirmation of necessary credentials.

418 Dewitt Avenue	West	Beginning at a point 66' north of the N/W apex of Dewitt Avenue / Kathryn Street and continuing to a point 22' north thereof;
14 Chestnut Street	North	Beginning at a point 158' west of the N/W apex of Chestnut Street / Passaic Avenue and continuing to a point 22' west thereof;
35 Cedar Hill Avenue	West	Beginning at a point 348' south of the S/W apex of Cedar Hill Avenue / Maier Street and continuing to a point 22' south thereof;
38 Mt. Pleasant Avenue	West	Beginning at a point 370' north of the N/W apex of Mt. Pleasant Avenue / Maier Street and continuing to a point 22' north thereof;
119 Heckel Street	North	Beginning at a point 256' north of the N/W apex of Heckel Street / Jeraldo Street and continuing to a point 22' north thereof;

118 Beech Street	East	Beginning at a point 116' north of the N/E apex of Beech Street / Greylock Parkway and continuing to a point 22' north thereof;
