"AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF BELLEVILLE, CHAPTER 8-16, HANDICAPPED PARKING SPACES"

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF BELLEVILLE, NEW JERSEY:

Section I: That Section 8, Schedule 16 of the entitled ordinance is hereby amended by <u>ADDING</u> the following location to be designated as a restricted parking space for use by the person who has been issued an identification card or special handicapped plates by the Division of Motor Vehicles. This location will expire one year after installation, pending re-evaluation of handicapped parking space request and confirmation of necessary credentials.
