AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP
OF BELLEVILLE, ESSEX COUNTY, NEW JERSEY, CHAPTER 8-16, ENTITLED
HANDICAPPED PARKING SPACES

Section I: that section 8, schedule 16 of the entitled ordinance is hereby amended by ADDING the following locations to be designated as a restricted parking space for use by the person who has been issued an identification card or special handicapped plates by the Division of Motor Vehicles. The following locations will expire one year after installation, pending re-evaluation of handicapped parking space request and confirmation of necessary credentials.

47 Adelaide Street	West	Beginning at a point 25' south of the S/W apex of Adelaide Street / Little Street and continuing to a point 22' south thereof;
47 Cleveland Street	South	Beginning at a point 200' west of the S/W apex of Cleveland Street / Washington Avenue and continuing to a point 22' west thereof;
35 Branch Brook Drive	West	Beginning at a point 315' north of the N/W apex of Branch Brook Drive / Belleville Ave and continuing to a point 22' north thereof;
200 Branch Brook Drive	East	Beginning at a point 339' north of the N/E apex of Branch Brook Drive / Belle Terrace and continuing to a point 22' north thereof;
58 Newark Place	East	Beginning at a point 243' south of the S/E apex of Newark Place / Meachum Street and continuing to a point 22' south thereof;
14 Mt. Prospect Avenue	East	Beginning at a point 158' north of the N/E apex of Mt. Prospect Avenue / Belleville




