**AN ORDINANCE APPROPRIATING \$77,195.00 FROM THE  
2023 CAPITAL IMPROVEMENT FUND FOR ENGINEERING DESIGN  
IMPROVEMENTS TO UNION GROVE, LISK HILL, DALY, AND  
LONGVIEW ROADS**

**WHEREAS,** the Township Committee hereby determined and states that is it in the best interest of the Township to authorize funding of the engineering design portion of a 2023 Capital Project for road improvements to Union Grove, Lisk Hill, Daly, and Longview Roads in an amount not to exceed \$77,195.00; and

**WHEREAS,** the sum of \$77,195.00 is hereby appropriated from the 2023 Capital Improvement Fund.

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Bedminster, in the County of Somerset and State of New Jersey, that such Sums being now available and having been provided for in the duly adopted budget of the Township of Bedminster in 2023.

Any grant moneys received for the purposes described above hereof shall be applied to direct payment of the cost of the improvements and shall reduce the amount authorized from the capital improvement fund to the extent that such funds are so used.


**BE IT FURTHER ORDAINED,** that the period of usefulness is five years or more. The capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Township Clerk and are available for public inspection.


**BE IT FURTHER ORDAINED,** this Ordinance shall take effect immediately upon final passage and publication according to law.
