ORDINANCE No. 2024-017**

**AN ORDINANCE AMENDING CHAPTER VII OF
THE TOWNSHIP OF BEDMINSTER GENERAL
ORDINANCES ENTITLED “TRAFFIC”**

BE IT ORDAINED by the Township Committee of the Township of Bedminster, in the County of Somerset, State of New Jersey as follows:

The Township of Bedminster Revised General Ordinances, is hereby amended, at Chapter VII entitled “Traffic” as follows (new language in **bold and underline** deleted language ~~double strikethrough~~):

7-3 TRAFFIC.

7-3.5 Stopping or Standing or Parking a Vehicle Prohibited During Certain Hours on Certain Streets.

No person shall stop or stand **or park** a vehicle between the hours and days specified in Schedule III upon any of the streets or parts of streets described in Schedule III of Chapter 7A.

7A-3 SCHEDULE III – NO STOPPING OR STANDING OR PARKING A VEHICLE

In accordance with the provisions of subsection 7-3.5, no person shall stop or stand **or park** a vehicle between the hours specified upon any of the following described streets or parts of streets. **Violators will be towed at their own cost and expense and subject to the fines set forth in Section 7-16 PENALTY.**




BE IT FURTHER ORDAINED, this Ordinance shall take effect immediately upon final passage and publication in accordance with law.
