

**ORDINANCE #11-07-05-1**

**AN ORDINANCE AMENDING ARTICLE 2.06 LIVESTOCK AND POULTRY;  
BEEKEEPING; ADDING SECTION 2.06.036 PROHIBITING LIVESTOCK  
UPON PAVED CITY STREETS EXCEPT UPON THE CITY'S DESIGNATED  
HORSE TRAIL OR DURING APPROVED CEREMONIAL USES SUCH AS  
PARADES AND MEMORIALS**

**WHEREAS**, the City Council has determined that livestock on paved City streets constitutes a hazard to the public health, safety and welfare of the Citizens;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BIG LAKE, TEXAS:**

THAT no livestock shall be ridden or herded upon any paved City streets except upon the City's Designated Horse Trail or during approved ceremonial uses such as parades and memorial events.

THAT the City of Big Lake's Designated Horse Trail shall be a square around the perimeter of the City consisting of Russek Street, Highway 137, 12<sup>th</sup> Street, and Louisiana Avenue.

**999. Penalties**

- 1. Any person, who violates any of the provisions of this chapter, shall upon conviction thereof, be fined in any sum neither less than \$10.00 nor more than \$2,000.00.**

All Ordinances or parts of Ordinances in conflict herewith are hereby repealed and declared of no further force and effect.

If any section or sub-section, clause, phrase or portion of this Ordinance shall be held unconstitutional or invalid by a court of competent jurisdiction, such section, sub-section, sentence, clause, phrase or portion shall be deemed to be a

separate, distinct and independent provision and such invalidity shall not affect the validity of the remaining portions.

**This Ordinance shall take effect upon completion of publication as provided by law.**

**PASSED AND APPROVED on First Reading at a Regular Meeting of the City Council on the 5th DAY OF JULY 2011, with all members voting "aye" for the passage of same.**

**PASSED AND APPROVED on Second Reading at a Regular Meeting of the City Council on the 19th DAY of JULY, 2011, with all members voting "aye" for the passage of same.**

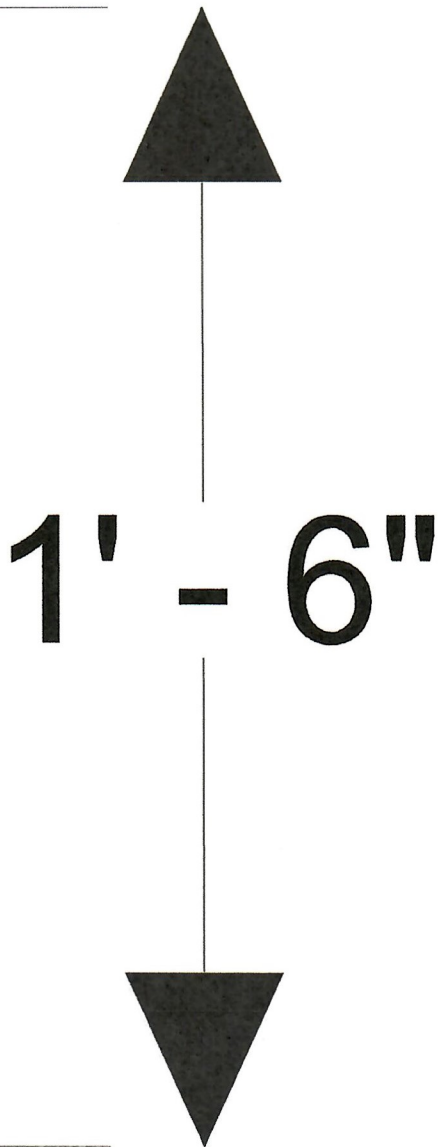
