**BE ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF BLASDELL AS FOLLOWS:**

To limit the term of office for Trustee and Mayor Positions to no more than two terms of four years each (eight years). Individuals may hold office for up to eight years in both the Trustee and Mayor, positions. Terms may or may not be contiguous (ex. Eight years in a row as Trustee vs. four years as Trustee then four years as Mayor the other four years as Trustee). If, after holding office for the maximum number of years in either position, an individual may abstain from running for either position for one term (four years), thereafter becoming eligible to run for either position again. New term limits are to begin with the positions elected into office March 18, 2009.

This local law shall take effect upon filing with the Secretary of State.




