AN ORDINANCE AMENDING SECTION 320.050 OF THE CODE OF ORDINANCES, CITY OF BLUE SPRINGS, MISSOURI, TO AMEND SPEED LIMITS ON COLBERN ROAD TO 35 MILES PER HOUR

WHEREAS, on January 2, 2024 the City of Blue Springs adopted Ordinance 5296 approving a Memorandum of Understanding between the City of Blue Springs and the City of Lake Lotawana for the provision of police services and maintenance at and around the intersection of Colbern Road; and

WHEREAS, in Section 3.C. of Ordinance 5296, the City is determined to be responsible for all speed limit signage for Colbern Road in the boundaries as designated in Exhibit A to Ordinance 5296; and

WHEREAS, the City now requests to lower the speed limit on Colbern Road, within the Lake Lotawana city limits, from 45 miles per hour to 35 miles per hour, to provide speed limit consistency for travelers between the neighboring jurisdictions along Colbern Road.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BLUE SPRINGS, MISSOURI, as follows:

- Section 1. That Title III, Schedule II Speed Limits, Table II-A "Speed Limits-Generally" Section 320.050 of the Code of Ordinances, City of Blue Springs, Missouri, is hereby amended to read as follows:
- Section 2. Road Location Speed Limit
 Colbern Road within the City Limits 35mph 45mph
 Southwest/Southeast
- Section 3. That this Ordinance shall be in full force and effect from and after its passage and approval.
- Section 4. Scrivener's Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this Ordinance, as determined by the City Clerk, may be corrected with the endorsement of the City Administrator without the need to come before the City Council.
