A LOCAL LAW TO OPT-OUT OF REAL PROPERTY TAX EXEMPTION FOR SOLAR AND WIND ENERGY SYSTEMS AND FARM WASTE ENERGY SYSTEMS

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF BOSTON AS FOLLOWS:

Section 1. Legislative Intent

It is the intent of the Town Board of Town of Boston to opt-out of the tax exemption for wind and solar energy systems and farm waste energy systems. Numerous solar and wind energy systems and farm waste energy systems are being planned and constructed around the area. Said solar and wind energy systems and farm waste energy systems are eligible for a real property tax exemption under New York State Real Property Tax Law. These tax exemptions eliminate the real property tax revenue available to the Town that the construction of these solar and wind energy systems and farm waste energy systems would otherwise generate. The New York State Real Property Tax Law allows municipalities to "opt-out" of said tax exemption.

Section 2. The following is hereby adopted:

Pursuant to New York State Real Property Tax Law § 487(8), the Boston Town Board hereby declares and provides that no exemption shall be applicable within its jurisdiction with respect to any Solar or Wind Energy System or Farm Waste Energy System constructed, erected or installed subsequent to the date of this Local Law.

Section 3. Miscellaneous

- A. This Local Law shall be deemed to supersede and repeal any other Local Laws to the extent therein inconsistent herewith.
- B. If any part of this Local Law shall be judicially declared invalid, void, unconstitutional or unenforceable, all unaffected provisions hereof shall survive such declaration and this Local Law shall remain in full force and effect as if the invalidated portion had not been enacted
- C. Nothing herein shall be deemed to be a waiver or restriction upon any rights and powers available to the Town of Boston to further regulate the subject matter of

this Local Law.

Section 4. Filing

A copy of this Local Law shall be filled with the State Board of Equalization and Assessment and with the President of the New York State Energy Research and Development Authority (NYSERDA) as is required by law.
