ORDINANCE NO. 929

AN ORDINANCE OF THE TOWNSHIP OF BOONTON, COUNTY OF MORRIS, STATE OF NEW JERSEY, REPEALING PART II, CHAPTER 143 “VEHICLES AND TRAFFIC,” ARTICLE IX, “ROCKAWAY VALLEY AERODOME FIELDS PARKING LOT,” SECTIONS 143-78 THRU -86 OF THE CODE OF THE TOWNSHIP OF BOONTON, AND ADOPTING IN ITS PLACE, CERTAIN NEW TRAFFIC CONTROL REGULATIONS APPLICABLE TO THE ROCKAWAY VALLEY AERODROM FIELDS PARKING LOT AND REGULATING THE USE OF SAID ROADWAYS, STREETS, DRIVEWAYS, AND PARKING LOTS.

WHEREAS, on December 28, 1998 the Township Committee of the Township of Boonton adopted, on second reading, Ordinance No. 588, which made the provisions of Subtitle One of Title 39 of the revised statutes of New Jersey applicable to the semi-public roads, streets, driveways, and parking lots at the Rockaway Valley Aerodome Fields (RVA) Parking Lot located in the Township of Boonton, County of Morris; and

WHEREAS, Ordinance No. 588, was adopted by the Township Committee at the request and written consent of the Rockaway Valley Road Association, LLC, and provisions of Ordinance No. 588 are currently set forth at Part II, Chapter 143, Article IX, §§143-78 thru 143-86 of the Code of the Township of Boonton; and

WHEREAS, the RVA Parking Lot has since been redesigned to enable more efficient traffic flow, site access and vehicle ingress and egress at the site; and

WHEREAS, the redesign of the RVA Parking Lot necessitates that the Township Committee take certain action to repeal, amend and replace various provisions §§143-78 thru 143-86 of the Code of the Township of Boonton with certain new provisions.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Boonton, County of Morris, State of New Jersey, as follows:

SECTION 1. Part II, Chapter 143, “Vehicles and Traffic,” Article IX entitled: “Rockaway Valley Aerodome Fields Parking Lot”, §§143-78 thru 143-86 of the Code of the Township of Boonton is hereby repealed in its entirety, and the following provisions be and are hereby adopted in its place:

§143-78 Applicability of Statute. In accordance with New Jersey Statutes, Title 39, Subtitle One, the following regulations shall be enforceable at the Rockaway Valley Aerodome Fields Parking Lot located in the Township of Boonton.

§143-79A General Parking.

- A. All vehicles must park in designated areas and between parking stall lines provided.
- B. No person shall stop or stand a vehicle upon any of the roads or parts of roads described below:

§143-79B Handicapped Parking. All handicapped stalls shall be 12 feet wide as shown on the attached site plan and signed with the R7-8 and R7-8P (Reserved Parking Sign and Penalty Plate), in the designed/designated parking areas for persons who have been issued a valid Handicapped Parking Permit or disability identification card by the Division of Motor Vehicles.

§143-80 Through Roads. The following roads or parts of roads are hereby designated as Through Roads. Signs shall be installed on the rear right side of each road intersection the Through Road except where yield signs are provided for in the designation.

Road "A"	Entire Length

§143-81 One-Way Roads. The following roads or parts of roads are hereby designated as One-Way roads in the direction indicated:

Name of Road	Direction	Limits
1. Road "B"	West	Entire Length
2. Road "C"	West (counterclockwise)	Entire Length
3. Road "D"	South	Entire Length
4. Road "I"	North	Entire Length
5. Road "J"	East	Portion (from Road "D" to Road "E" And from Road "H" to Road "I")

§143-82 Two-Way Roads. The following roads or parts of roads are hereby designated as Two-Way roads in the direction indicated:

Name of Road	Direction	Limits
1. Road "E"	North/South	Entire Length
2. Road "F"	North/South	Entire Length
3. Road "G"	North/South	Entire Length
4. Road "H"	North/South	Entire Length
5. Road "J"	East/West	Portion (from Road "E" to Road "H")

§143-83 Speed Limits.

A. The speed limit for both directions of traffic in the parking lot(s) shall be 15 miles per hour (mph).

B. The speed limit for both directions of travel on the following roadways are:

Name of Roads	M.P.H.	Limits
All Roads	15	Entire Length

C. Regulatory and warning signs shall be erected and maintained to effect the above-designated speed limits authorized by the New Jersey Department of Transportation.

§143-84 Tow Away Zones. Any vehicle parked or standing as to obstruct or impede the normal flow of traffic or to block entrances or exit ways, intersections, loading zones, oil fills, sidewalks, any grassy area, pedestrian walkway, cross-walks, or present in any way a safety or traffic hazard may be removed at the direction of Township Police by towing the vehicle at the owner's expense.

§143-85 Signage. All signs, posts, or other necessary materials shall be installed and paid for by the Township of Boonton. All signage shall conform to the current Manual on Traffic Control Devices, pursuant to N.J.S.A. 39:4-198 and N.J.S.A. 39:4-183.27.

§143-86 Violations and Penalties. Unless another penalty is expressly provided by New Jersey Statute, including as set forth under Title 39 of the revised statutes of New Jersey, every person convicted of a violation of this Article or any supplement thereto shall be liable to penalty of not more than one hundred dollars (\$100.00) or imprisonment for a term not exceeding fifteen (15) days or both.

SECTION 2. The site plan referenced in, and made part of Chapter 143, "Vehicles and Traffic," Article IX entitled: "Rockaway Valley Aerodome Fields Parking Lot", be and is hereby repealed and the revised "Final Plan Parking Lot Improvements," prepared by Bowman Consulting Group, LTD, last dated September 6, 2023 depicting the affected locations that are the subject of this Ordinance, be and is hereby adopted in its place.

SECTION 3. All ordinances, resolutions, regulations or parts of ordinances, resolutions and regulations of the Township of Boonton which are inconsistent herewith the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such a decision shall not affect the remaining portions of this Ordinance.

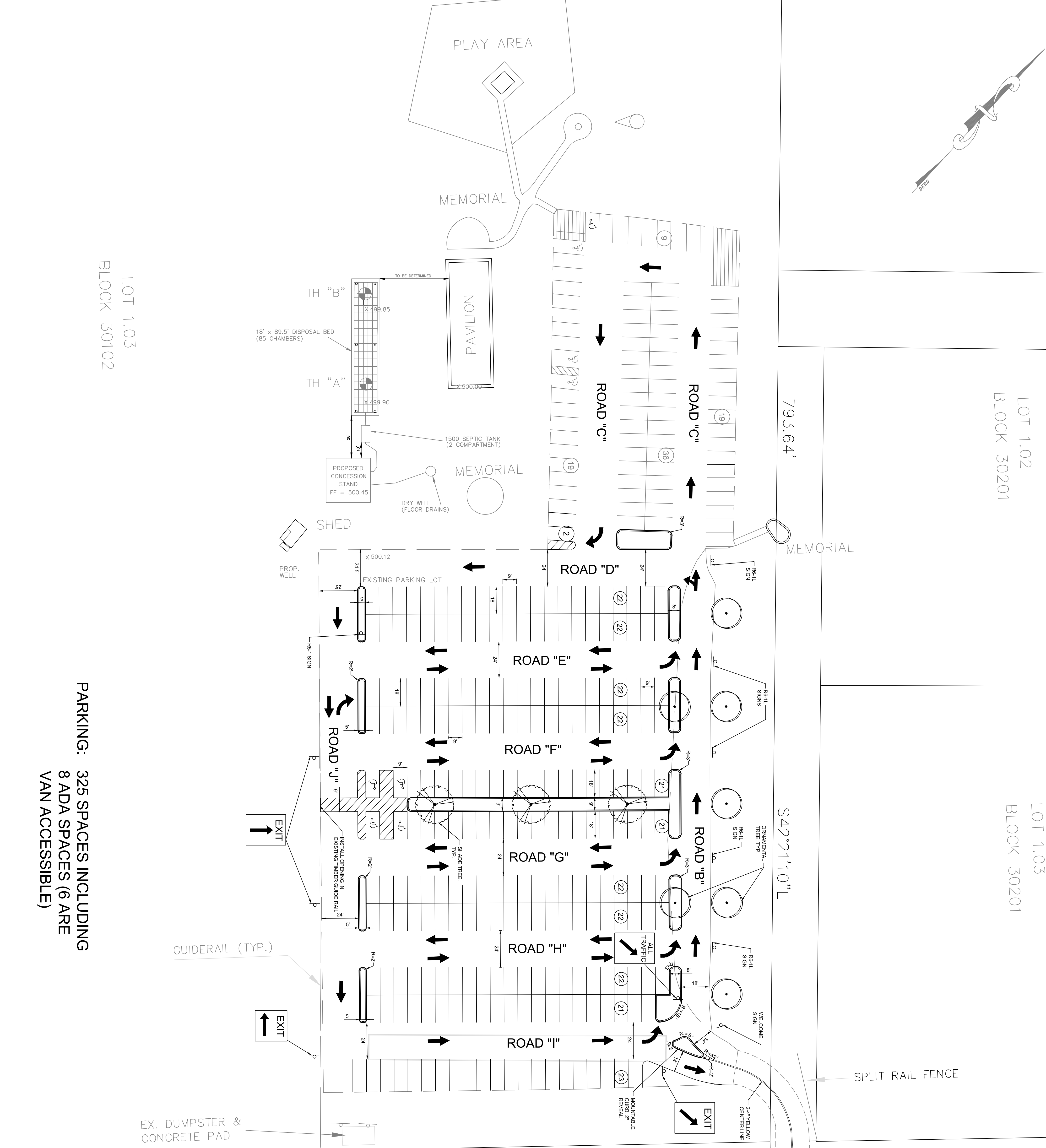
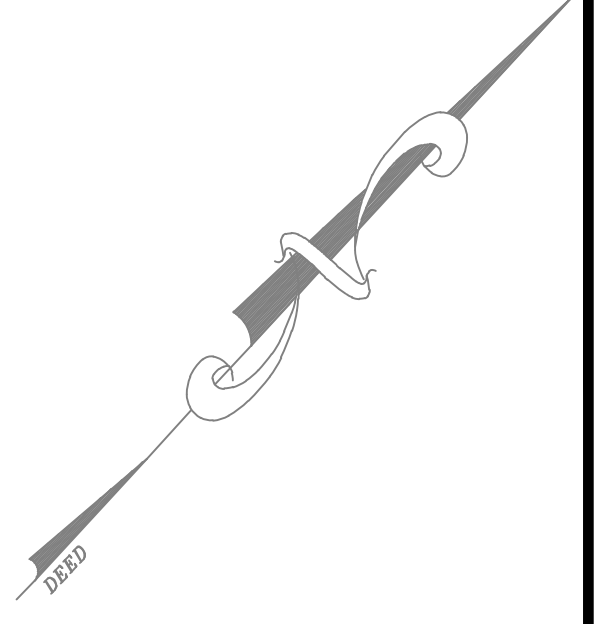
SECTION 5. This Ordinance shall take effect immediately upon final passage and publication in the manner according to law.

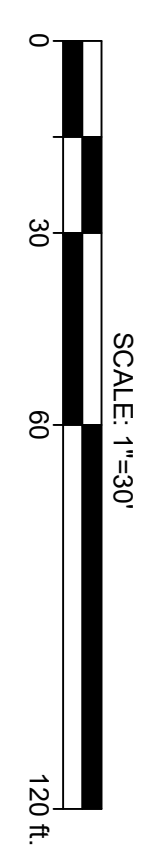

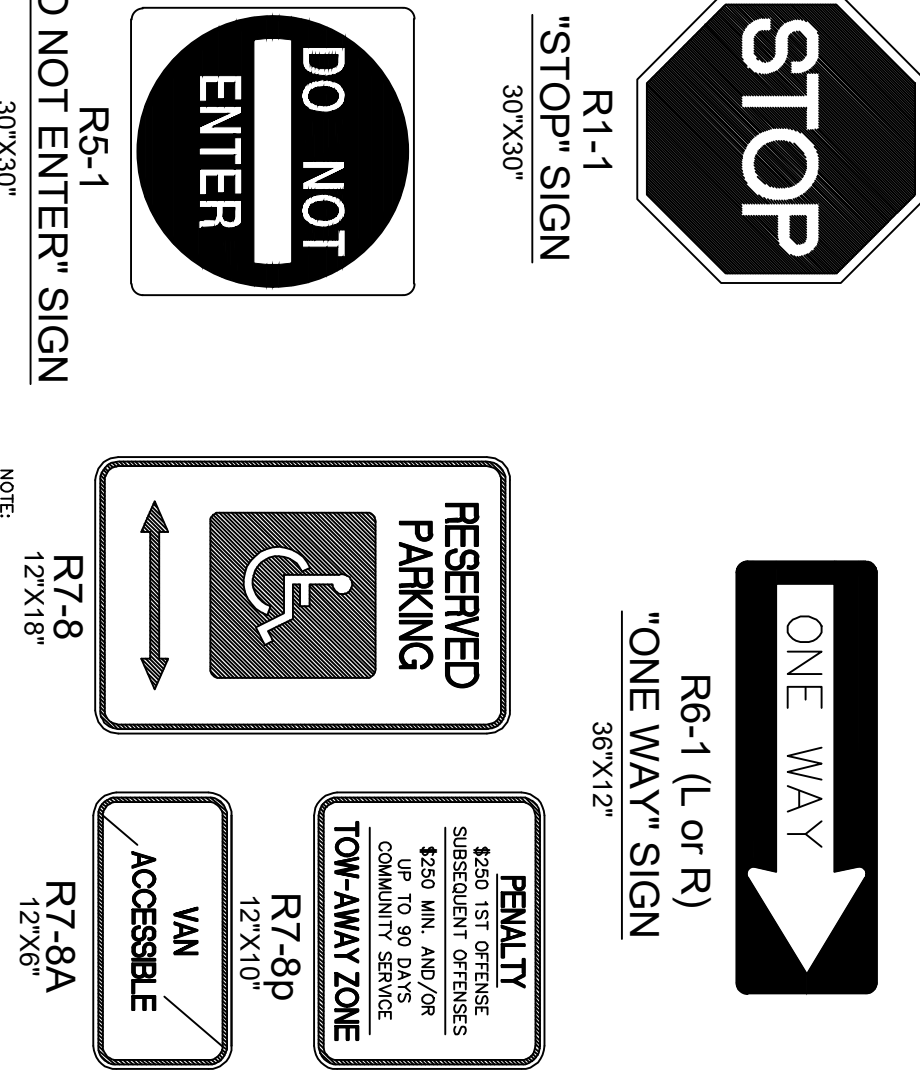
