ORDINANCE 2025-18

AN ORDINANCE AMENDING THE CODE OF THE CITY OF BORDENTOWN AT CHAPTER 258 ENTITLED “VEHICLES AND TRAFFIC” TO ADD NEW PARKING RESTRICTIONS ON CERTAIN STREETS

WHEREAS like many historic cities, the City of Bordentown (“the City”) has limited parking on certain streets at certain times; and

WHEREAS Chapter 258 of the Code of the City of Bordentown (the “City Code”) provides the parking regulations for the City; and

WHEREAS Section 12 of the City Code entitled “Parking time limited on certain streets” provides locations and times wherein parking is illegal; and

WHEREAS the Board of Commissioners of the City of Bordentown finds that it is within the public interest to amend Section 12 of Chapter 258 to implement new parking restrictions; and

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the City of Bordentown, County of Burlington, State of New Jersey, that Section 12 of Chapter 258 of the Code of the City of Bordentown shall be amended and supplemented at Chapter 258, entitled “Parking time limited on certain streets,” to read in relevant part as follows (underlined text illustrates additions, strikethrough text illustrates deletions):

§ 258-12 Parking time limited on certain streets.

[Amended 12-9-25 by Ord. No. 2025-18]

No person shall park a vehicle for longer than the time limit between the hours listed on any day (except Sundays and public holidays) upon any of the streets or parts of streets described.

Crosswicks Street	Both	2 hours/ <u>11:00 a.m.</u> to <u>9:00 p.m.</u>	Between Farnsworth Avenue and 270 feet east thereof
Farnsworth Avenue [Amended 11-14-2012 by Ord. No. 2012-12]	Both	3 hours weekdays and Saturdays/ <u>11:00 a.m.</u> - <u>9:00 p.m.</u>	Railroad Avenue and Burlington Streets
Walnut Street	North	10 min./8:00 a.m. to 6:00 p.m.	From a point 180 feet west of Farnsworth Avenue to a point 250 feet west of Farnsworth Avenue

<u>Farnsworth Avenue</u>	<u>East</u>	<u>15 mins</u>	<u>1 parking space southerly from the intersection of Farnsworth and Second Street Public Parking Lot</u>
<u>Farnsworth Avenue</u>	<u>West</u>	<u>15 mins</u>	<u>1 parking space after the hydrant southerly from the intersection of Farnsworth and W. Church Street</u>
<u>Crosswicks Avenue</u>	<u>Northerly</u>	<u>15 mins</u>	<u>1 parking space easterly from the intersection of Farnsworth and Crosswicks.</u>

- A. Any person parking a motor vehicle in excess of the time allotted shall be liable to a fine of \$50.

REPEALER, SEVERABILITY, AND EFFECTIVE DATE

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Board of Commissioners hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
