## **ORDINANCE 16-24**

AN ORDINANCE, AMENDING A SECTION WITHIN THE TOWN CODE OF THE TOWN OF BOONTON, PART II GENERAL LEGISLATION, CHAPTER 137, FIRE PREVENTION, ARTICLE I UNIFORM FIRE CODE, ONLY AS TO 137-8 ADDITIONAL REQUIRED INSPECTIONS AND FEES AND 137-9 PERMIT FEES, AND UPDATING 130-12 FIRE PREVENTION

**WHEREAS**, in order to maintain the public's health, safety and welfare, the Mayor and Town Council of the Town of Boonton recognize the need to update Chapter 130-12, Fire prevention; and

**WHEREAS**, such changes are required to update the various fees as reflected within Sections 137-8 Additional required inspections and fee and 13-8 Permit fees, to more fairly represent and offset the costs as incurred by the Town; and

**WHEREAS**, the Mayor and Town Council wish to update the Town of Boonton Code of Ordinances to reflect these changes and updated fees, for the public's knowledge.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF BOONTON, COUNTY OF MORRIS, STATE OF NEW JERSEY, THAT SECTION 130-12 OF THE TOWN CODE BE UPDATED ONLY AS FOLLOWS:
