AN ORDINANCE AMENDING MABERY'S ACRE DE TERRE BEING A SUBDIVISION PLAT, ALL OF LOT 1, BLOCK 75, TOWN OF BONNE TERRE, ST. FRANCOIS COUNTY, MISSOURI, CITY OF BONNE TERRE, COMMONLY REFERRED TO AS 403 GROVE STREET, BONNE TERRE, ST. FRANCOIS COUNTY MISSOURI, AND APPROVING THE AMENDED PLAT OF MABERY'S ACRE DE TERRE BEING A SUBDIVISION PLAT, ALL OF LOT 1, BLOCK 75, TOWN OF BONNE TERRE, ST. FRANCOIS COUNTY, MISSOURI, CITY OF BONNE TERRE, AS SET FORTH IN THE AMENDED PLAT ATTACHED HERETO AND MADE A PART HEREOF.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BONNE TERRE, MISSOURI, AS FOLLOWS:

SECTION 1. The City of Bonne Terre, Missouri has received a request to amend Mabery's Acre De Terre, being a Subdivision Plat, all of Lot 1, Block 75, Town of Bonne Terre, St. Francois County, Missouri, City of Bonne Terre, commonly referred to as 403 Grove Street, Bonne Terre, St. Francois County, Missouri.

SECTION 2. In consideration of the recommendation for approval of said request made by the Planning and Zoning Committee, hearing and consideration the Board of Alderman of the City of Bonne Terre, Missouri, the subdivision of Mabery's Acre De Terre, being a Subdivision Plat, all of Lot 1, Block 75, Town of Bonne Terre, St. Francois County, Missouri, City of Bonne Terre, commonly referred to as 403 Grove Street, Bonne Terre, St. Francois County, Missouri is hereby approve and the plat is hereby amended, as set forth in the amended plat attached hereto and incorporated herein.

SECTION 3. All Municipal Ordinances, or parts thereof, in conflict with this Ordinance are hereby repealed, as to the extent they cannot be reconciled herewith.

SECTION 4. This Ordinance shall be in full force and effect from and after its date of passage and approval.
