

**TOWNSHIP OF BORDENTOWN**

**ORDINANCE No. 2024-01**

**AN ORDINANCE TO AMEND SECTION 475-10 OF THE CODE OF THE TOWNSHIP OF BORDENTOWN ENTITLED “BUS STOPS”**

**WHEREAS**, the Township Committee of the Township of Bordentown desires to expand convenient access to mass transit its residents and visitors to the Township; and

**NOW THEREFORE, BE IT ORDAINED AND ENACTED** by the Township Committee of the Township of Bordentown, County of Burlington, State of New Jersey, that the Bordentown Municipal Code be amended as follows:

Section 1 Section 475-10 of the Bordentown Municipal Code entitled “Bus Stops” is hereby amended as follows (additions shown as **thus**, deletions shown as ~~thus~~):

**§475-10 Bus Stops**

It shall be unlawful for any person to park, stop or stand any motor vehicle other than a bus in any location described as a bus stop. The following described locations are hereby designated as bus stops:

U.S. Route 206, northbound, at Stanton Avenue (far side)-NJ Transit ID #14173	East	Beginning at the northerly curbline of Stanton Avenue and extending 100 feet northerly therefrom
U.S. Route 206, northbound, at Maple Avenue (near side) - NJ Transit ID #14174	East	Beginning at the southerly curbline of Maple Avenue and extending 105 feet southerly therefrom
U.S. Route 206, northbound, at Spruce Avenue (near side) - NJ Transit ID #14175	East	Beginning at the southerly curbline of Spruce Avenue and extending 105 feet southerly therefrom
U.S. Route 206, northbound, at Martin Avenue (near side) - NJ Transit ID #14176	East	Beginning at the southerly curbline of Martin Avenue and extending 105 feet southerly therefrom
U.S. Route 206, northbound, at Carmen Avenue (near side) - NJ Transit ID #14178	East	Beginning at the prolongation of the southerly curbline of Carmen Avenue and extending 105 feet southerly therefrom
U.S. Route 206, southbound, at Carmen Avenue (near side) - NJ Transit ID #14180	West	Beginning at the northerly curbline of Carmen Avenue and extending 105 feet northerly therefrom
U.S. Route 206, southbound, between Nissim Avenue and Hilltop Avenue (midblock) - NJ Transit ID #14181	West	Beginning at a point 800 feet south of the southerly curbline of Nissim Avenue and extending 135 feet southerly therefrom

U.S. Route 206, southbound, between Sylvan Glen Road and Maple Avenue (midblock) - NJ Transit ID #14182	West	Beginning 465 feet south of the southerly curbline of Sylvan Glen Road and extending 135 feet southerly therefrom
U.S. Route 206, southbound, at Maple Avenue (far side) - NJ Transit ID #14183	West	Beginning at the prolongation of the southerly curbline of Maple Avenue and extending 100 feet southerly therefrom
U.S. Route 206, southbound, at Stanton Avenue (near side) - NJ Transit ID #14184	West	Beginning at the northerly curbline of Stanton Avenue and extending 105 feet northerly therefrom
West Burlington Street (CR 662), eastbound, (southerly side) Transit ID#33209	South	Between Union Street and I-295 Overpass--(mid-block) beginning 1,815 feet east of the easterly curb line of Union Street and extending 135 feet easterly therefrom (same side as Juvenile Medium Security Facility) (JMSF)
West Burlington Street (CR 662), westbound, (northerly side) Transit ID#33210	North	Between Union Street and I-295 Overpass--(mid-block) beginning 976 feet west of the westerly curb line of I-295 overpass and extending 135 feet easterly therefrom (across from Juvenile Medium Security Facility) (JMSF)
<b><u>West Burlington Street (CR 662), westbound, Transit ID# 33201</u></b>	<b><u>North</u></b>	<b><u>Westbound at Schindler Way, Near Side, beginning at the easterly curbline of Schindler Way extending 105 feet easterly therefrom.</u></b>
<b><u>West Burlington Street (CR 662), eastbound, Transit ID# 33200</u></b>	<b><u>South</u></b>	<b><u>Eastbound at Schindler Way, Far Side Prolongation, beginning at the prolongation of the easterly curbline of Schindler Way extending 100 feet easterly therefrom.</u></b>

**Section 2. Repealer.** Any and all ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.


**Section 3. Severability.** In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable to any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that is allows the Township to meet the goals of the Ordinance.

**Section 4. Effective Date.** This Ordinance shall take effect upon proper passage in accordance with the law.
