TOWNSHIP OF BORDENTOWN

ORDINANCE No. 2024-15

AN ORDINANCE TO AMEND SECTION 475-5 OF THE CODE OF THE TOWNSHIP OF BORDENTOWN ENTITLED "SPEED LIMITS"

WHEREAS, the Township Committee of the Township of Bordentown desires to lower the allowable speed limit on Groveville Road between Klein Drive and US Route 130 due to the section of roads proximity to Northern Community Park and the increased pedestrian traffic from adjacent residential neighborhoods; and

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Bordentown, County of Burlington, State of New Jersey, that the Bordentown Municipal Code be amended as follows:

Section 1 Section 475-5 of the Bordentown Municipal Code entitled "Speed Limits" is hereby amended as follows:

§475-5 Speed Limits

A. Limits established. The speed limits for traffic moving in both directions on the streets named herein shall be as follows: [Amended at time of adoption of Code (see Ch. 1, General Provisions, Art. I)]

Name of Street	Speed Limits (mph)	Location
Bordentown-Hedding Road	35	
Bordentown-South Amboy Turnpike	30	From Highbridge Road to US Route 130
Dunn's Mill Road	35	Between U.S. Route 130 and U.S. Route 206, except for 25 mph when passing through the Bordentown Regional High School Zone during recess or while the presence of children is clearly visible from the roadway or while children are going to or leaving school, during opening or closing hours
Groveville Road	30	From U.S. Route 206 to 150 feet east of the center of East Drive, thence, 40 mph to U.S. Route 130, thence, 35 mph to Hogback Road

Hogback Road [Amended 11-9-2009-by Ord. No. 2009-29]	35	Except for as 25 mph school speed limit when passing by the Bordentown Regional High School during recess when the presence of children is clearly visible from the roadway or while children are going to or leaving school during opening or closing hours
Ward Avenue	35	Between U.S. Route 206/130 and Hogback Road, except for a 25-mph school speed limit when passing through the Peter Muschal School Zone during recess when the presence of children is clearly visible from the roadway or while children are going to or leaving school during opening or closing hours
Williamsburg Drive	West	Entire Length

<u>Section 2</u>. Repealer. Any and all ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.

<u>Section 3</u>. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable to any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that is allows the Township to meet the goals of the Ordinance.

Section 4. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
