A Local Law Increasing the Maximum Exemption for the Alternative Veterans Exemption under Section 458-a of the Real Property Tax Law of the State of New York

## BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF BRANT AS FOLLOWS:

- 1. Pursuant to the provisions of Subparagraph (ii) of Subdivision 2 of Section 458-a of the Real Property Tax Law of the State of New York, the maximum allowable exemption of paragraphs (a), (b) and (c) of Subdivision 2 of Section 458-a of such law is hereby increased to \$30,000.00, \$20,000.00 and \$100,000.00 and Chapter 145, Article II, Section 145-2 of the Town of Brant Code shall be amended accordingly.
- 2. This law shall take effect immediately upon filing with the Office of the Secretary of State.
