TOWN OF BRANT LOCAL LAW No. 3 – 2023

A Local Law Amending Certain Provisions of Chapter 145, Article IV of the Brant Town Code entitled "Exemption for Persons with Disabilities and Limited Income."

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF BRANT AS FOLLOWS:

1. The following provisions of Chapter 145 ("Taxation"), Article IV, ("Exemption for Persons with Disabilities and Limited Income") of the Town of Brant Code are hereby amended to read as follows:

Section 145-5. Exemption Granted.

Real property owned by one or more persons, or real property owned by a husband, wife, or both, or by siblings, at least one of whom has a disability as defined herein, and whose income, as defined herein, is limited by reason of such disability, shall be exempt from taxation by the Town of Brant, as authorized by Section 459-c of the Real Property Tax Law, up to the extent of fifty (50) percent of assessed valuation thereof as provided herein.

Section 145-6. Amount of Exemption.

The Town of Brant hereby adopts the annual income and exemption schedule most recently adopted by the Erie County Legislature for partial exemption from real property taxation by the Town of Brant, pursuant to New York State Real Property Tax Law Section 459-c to persons with disabilities and limited income.

Pursuant to the local option granted by said Section 459-c, distributions from individual retirement accounts and individual retirement annuities shall be included when calculating adjusted gross income for purposes of this section.

2. This law shall take effect immediately upon filing with the Office of the Secretary of State as provided in Section 27 of the Municipal Home Rule Law.
